Energy Efficiency and Conservation Block Grant (EECBG)	\$5,155,300	The funds will be used for energy efficiency home retrofits, transportation efficiency programs, financial incentive programs and enhanced public education programs on energy efficiency and greenhouse gas reduction. View Federal Report
Local Energy Assurance Planning (LEAP) Initiative	\$300,000	To develop a local energy assurance plan.

AZ Housing Authority -Public Housing Capital Fund	\$2,085,435	The funds will be used for public housing improvements. View Federal Report
Community Development Block Grant (CDBG)*	\$1,657,320	Funding will be used for the construction of transitional housing, public housing, civic center improvements, and park facilities. View Federal Report
Emergency Shelter Grants Program	\$2,534,340	Provides financial assistance and services to either prevent individuals and families from becoming homeless or help those who are homeless to be quickly re-housed and stabilized. Funds can be used to provide prevention or re-housing, data collection and program management. View Federal Report
Neighborhood Stabilization Program 1 (NSP1)	\$7,286,911	Funding will be used to purchase foreclosed homes for rehabilitation, resale and rental.
Neighborhood Stabilization Program 2 (NSP2)	\$4,200,000	Funding will be used to purchase foreclosed homes for rehabilitation, resale and rental.

Recovery Act: Edward Byrne Justice Assistance Grant (JAG) Program (Local Solicitation)	\$3,100,651	The City of Tucson is the Prime Recipient of \$3,100,651. The City of Tucson, Pima County, City of South Tucson, Towns of Sahuarita, Oro Valley, and Marana have identified 7 projects based on this funding. The Tucson Police Department will use its allocation of \$1,617,885 for law enforcement programs to support technological applications providing increased operational capabilities in communications and emergency response and to increase the capability to effectively process and analyze evidence. Criminal Justice Records Improvement Grant	\$11,576	To be used for overtime for reduction in the backlog of arrest records not yet submitted to local, state and federal agencies

Edward Byrne Justice Assistance Grant (JAG) Program	\$360,064	Funds will be used to prosecute a variety of misdemeanor drug offenses and to litigate civil forfeitures related to drug offenses.
TRANSPORTATION		
Federal Highway Administration	\$7,107,000	This pavement preservation package will encompass 10 roadways and will include rubber chip or mill inlay. The City of Tucson expects to receive approximately \$11 million for this project: \$7.1 million in ARRA funds, \$3 million in Surface Transportation Program (STP), and \$700,000 from the Regional Transportation Authority (RTA).
Federal Highway Administration	\$6,000,000	This pavement preservation project will resurface, reconstruct and rehabilitate 5 roadways including mill, overlay and bike lanes.
Federal Highway Administration	\$276,000	This sidewalk project will provide Americans with Disability Act (ADA) assessable ramps and pedestrian lighting on 4th Ave. between 17th St. and 22nd St. The City is expecting to receive \$276,000 in ARRA funds and \$191,000 from the Regional Transportation Authority (RTA).
Federal Highway Administration	\$514,000	This project will fill sidewalk gaps and install Americans with Disability Act (ADA) assessable ramps and pedestrian lighting on 4th Avenue.
Federal Transit Administration Public Transit Investment Grant	\$16,022,390	Funds will be used to complete the construction of the Northwest Sun Tran Bus Storage and Maintenance Facility. When complete, the new facility will house bus storage, maintenance and operations to accommodate 250 buses. View Federal Report
Transportation Investment Generating Economic Recovery (TIGER)	\$63,000,000	To fund the Tucson Modern Streetcar.
