We, the undersigned, residents of the City of Tucson, Arizona, and duly qualified electors therein, do hereby submit and propose to you, for adoption, the following ordinance, and request that action be taken by you relative to the adoption or rejection of such proposed ordinance, at the earliest possible moment, and that the same be forthwith submitted to a vote of the people, to-wit:

TUCSON WARD ONLY VOTING

TUCSON ARIZONA CHARTER AND GENERAL ORDINANCES

PART 1 CHARTER

CHAPTER XVI ELECTIONS

Section 9. Mayor nominated and elected at large; councilmen **MEMBERS** nominated from wards **AND** elected at large **BY WARD**.

Beginning in the year ~~1930~~ 2021, and continuing thereafter, the mayor shall be nominated from and elected by the voters of the city at large, and the councilmen ~~MEMBERS~~ shall be nominated each from, and by the respective voters of, the ward in which ~~he~~ **THEY** resides, and shall be elected by the voters of the ~~city at large~~ **WARD IN WHICH THEY RESIDE**.

The Proposition changes Chapter XVI, Section 9 of the City Charter to specify voting for Council members be restricted to each particular Ward.

City-wide voting for Mayor is not affected.

The Proposition also changes the title of the Ward representative from “Councilman” to the more inclusive term “Council Member.”
