In accordance with new State Open Meeting Law requirements, all meeting notices and agendas must be posted on the City's website. This requirement applies regardless of where the official posting is located. Meeting notices and agendas should be emailed as a Word document to BoardsandCommissions@tucsonaz.gov. Additionally, the City Clerk's office will also accept faxed meeting notices at 791-4017 during regular office hours. All faxed meeting notices should be confirmed with a follow-up phone call to avoid untimely posting.
