**Board Office – Staff Classification Survey**

Ms. Martinez stated that she submitted a job description questionnaire on December 14, 2006 to Human Resources. She asked for the results of the survey and no one in the department had any information regarding it.

She further stated that she was given the survey to fill out on December 13, 2006 and was told it had to be turned in mid-morning on December 14, 2006; she turned it in to Mr. Douthitt at 8:00 a.m. on December 14, 2006.

Also there is a memo that is in the back of the packet and it states that Human Resources has a deadline of January 26, 2007, but have never notified the board office of any results.

Mr. Garrison stated that the Board has been trying to have Ms. Martinez in a position to be compensated for her responsibilities. The responsibilities will increase due to two Board elections that are to be held late 2007 and again early 2008 for Board Members. He further stated that had spoken with Mr. Douthitt and he indicated that he was interested in this reclassification. He said that he did not care what Ms. Martinez is called as long as it is applicable to her responsibilities.

Mr. Walkup said that he would personally look into it.

Mr. Ladenburg stated that what he had heard from his director was that all classifications are on hold at the moment.

Ms. Martinez said that Mr. Ladenburg had sent her a power point from Human Resources that was titled "Guidelines for Compensation Plan" and on page three, it had a bullet that said Challenges for Continues Work FY2009 and beyond. After that bullet it states; "Investigate PSPRS costs fully & discuss". She ask if anyone new what that meant?

Mr. Lininger asked if staff has approached Ms. Bezaury.

Ms. Martinez said no staff has only asked within the finance department.

Mr. McKendrick stated that the power point says that they are going to work hard next year, and do not like what is written there.

Mr. Garrison stated that this problem goes way back.

Mr. Lininger stated it goes back at least twenty years.

Mr. Walkup said nothing should take twenty years. He said that he would find out why they are holding the survey results.
