9. LEGISLATION

Police & Fire

The Board members reviewed the 2008 legislation.

Ms. Martinez stated that each month she would update the Board Members on the current legislation.

Ms. Pickens asked if there were any concerns regarding the current legislation.

Mr. Ladenburg asked about House Bill 2058 and the timeline involved with the disability process.

Ms. Martinez explained the process of a disability application.

Mr. McEvoy stated that he had concerns with House Bill 2058; he interpreted this legislation to mean that, when a member files his paperwork in the board office, the local board has 60 days from that date to make a determination on his claim or else the claim is deemed approved. The problem is that, under our normal process, it takes approximately 60 days under the best circumstances for the local board to hear and decide whether to grant a member's application. Moreover, if a member is aware of this "deemed approved" law (assuming it passes the legislature and governor), the member on purpose can slow the process (for example, by not being readily available for a medical exam by the local board's doctor) to the point of getting to the "deemed

approved” status. That will result in members being approved on applications that, under the law, should not be approved, thereby adversely affecting the PSPRS financial viability.

After some discussion, **MOTION** by Mr. Gurr, seconded by Mr. Kragnes to request that staff draft a letter to the letter to the fund manager, and Mr. Gurr will contact the police union. Motion **CARRIED** unanimously. (Mr. Walkup absent/excused)

Medical Benefits

Ms. Martinez stated that Mr. Roscoe Ealey called the board office regarding his medical benefits; he was concerned about the statement in the paperwork that he had to sign in order to receive benefits, it states, "The benefits offered for retirees and dependents may change if these benefits revised in the future. It should not be construed as giving to any retiree or dependent any vested rights that cannot be modified by subsequent revision of benefits." She said that she spoke to Mr. Ladenburg regarding it.

Mr. Ladenburg stated it is in a standard form for employee benefits use, the verbiage was written by the city attorney's office years ago and means that if the city changes providers the retirees will also change provider.

Mr. Tamietti said that maybe the verbiage should be revised so a retiring employee would feel comfortable signing it.

Mr. Ladenburg stated that he would look into it.
