- You may be eligible to attend Defensive Driving School if you meet **ALL** of the following conditions:
  - Your ticket was for a **civil** moving violation
  - You have not attended Defensive Driving School for any Arizona civil traffic violation in the last 12 months
  - Your ticket (complaint) was not issued as the result of a collision in which any person was seriously injured or killed
  - Your case is not set for a hearing
  - Commercial Driver License (CDL) holders are not eligible for Defensive Driving School
- Advantages of Attending Defensive Driving School:**
- You will not pay a fine for one traffic violation
  - You will not have to go to court for that violation
  - That violation will be dismissed
  - There are no points against your license for that violation

Arizona states allow you to complete a Defensive Driving School (DDS) program once every 12 months to remove one eligible traffic violation from your driving record. Eligibility is determined by the date of violation. If you are eligible, the DDS program is available for one violation on your ticket (complaint) if it is listed in the shaded areas on page 5 or 6 of this bond card. All additional violations on your ticket (complaint) must be processed through the court.
