## Purpose

The purpose of ESF #13 is to identify law enforcement and security roles and responsibilities within the City of Tucson during an Incident of Local or Regional Significance.

## Scope

ESF #13 discusses maintaining law and order through traffic and crowd control, providing security for vital facilities and supplies, controlling access and egress to incident scenes and vacated areas, and preventing and investigating crimes against people and property.

During an Incident of Local or Regional Significance the Tucson Police Department will coordinate with other regional, state, and federal law enforcement organizations to facilitate essential law enforcement operations.

The Tucson Police Department will observe normal policies and procedures whenever possible, but may make adjustments when necessary to protect life, stabilize the incident, and protect property and the environment.

## **Situation**

### **Emergency/Disaster Conditions and Hazards**

The City of Tucson will periodically experience emergency situations that may overwhelm current law enforcement capabilities. Equipment and personnel may be damaged or unavailable at times when they are most needed. The Pima County Hazard Mitigation Plan (draft form October 2005) describes situations that may impact resource availability in our area. Additionally, the Base Plan to this Emergency Operations Plan describes situations and planning assumptions that may impact resource availability in our area.

### **Planning Assumptions**

- The Tucson Police Department maintains a 24-hour/7-day a week operational capability. Other regional law enforcement and corrections agencies also maintain a 24/7 capability
- The Tucson Police Department will fully utilize local resources before requesting help from county and regional resources, at the discretion of the Chief of Police
- Assistance between law enforcement agencies is facilitated by mutual aid agreements in effect for law enforcement agencies which operate in the region
- The Arizona Department of Public Safety maintains jurisdiction for traffic enforcement and control on all state and interstate roadways within the region

## **Concept of Operations**

### **General**

In times of an emergency or disaster, law enforcement agencies are called upon to perform a wide variety of functions. These include, but are not limited to:

- warning and evacuation
- providing security for vital infrastructure and supplies
- conducting search and rescue
- controlling access/egress to incident locations
- enforcing traffic regulations
- investigating crime
- responding with other types of services to unusual events

During a citywide event, coordination of law enforcement resources will be managed by the Tucson Police Department with assistance from other regional agencies. Law enforcement resources provided by other agencies will remain under the command of their parent agency.

The Tucson Police Department will utilize their Major Action Plan (MAP) in determining resource mobilization, response to calls for service, and staffing issues.

## **Comprehensive Emergency Management**

### **Preparedness**

ESF #13 primary and support agencies are responsible for the following preparedness measures:

- Review and revise their Standard Operating Procedures (SOPs)/Standard Operating Guidelines (SOGs)/Field Operating Guidelines (FOGs) annually
- Establish procedures for alerting their own personnel and other key employees in an Incident of Local or Regional Significance
- Update equipment and resource listings on an annual or more frequent basis, and distribute them appropriately
- Revise mutual aid agreements as needed
- Train employees on specific ESF functions
- Regularly attend scheduled tabletop exercises and all other applicable training events
- Review and analyze lessons learned in emergency/disaster incidents that have occurred elsewhere, and make appropriate corrections/additions to their respective SOPs/SOGs and this ESF

### **Response**

ESF #13 primary and support agencies are responsible for ensuring that the following response items are fully addressed:

- Establish and maintain contact with the Incident Commander and/or appropriate Emergency Operations Center (EOC) for instructions
- Maintain ongoing information exchange with ESF #5- Emergency Management
- Maintain complete and accurate documentation of all related costs, actions, and communications

### **Recovery**

ESF #13 primary and support agencies are responsible for ensuring the following:

- Consult with ESF #5 and ESF #14 – Long-term Community Recovery & Mitigation regarding recovery strategy
- Assess losses of equipment and personnel, develop estimates of monetary loss, and identify possible funding sources
- Assess the need for critical incident stress management for personnel

## Mitigation/Prevention

---

ESF #13 primary and support agencies are responsible for the following mitigation/prevention items:

- Conduct threat, risk, and vulnerability assessments of key ESF infrastructure
  - Review and analyze lessons learned in emergency/disaster incidents that have occurred elsewhere, and make changes where applicable
  - Replace equipment, vehicles and/or personnel

## Responsibilities

### **Coordinating and Primary Agency: Tucson Police Department**

The City of Tucson Police Department is responsible for liaison with other regional law enforcement agencies in an Incident of Local or Regional Significance. Other specific responsibilities are as follows:

- Pre-incident planning and coordination
- Manage the financial aspects of the ESF #13 response, including identification of funding sources for mission assignments and/or reimbursable agreements
- Maintain ongoing contact with ESF primary and support agencies
- Conduct periodic ESF meetings and/or conference calls
- Coordinate ESF activities relating to Incidents of Local or Regional Significance, catastrophic incident planning, and critical infrastructure preparedness, as appropriate
- Coordinate training and strategy with the appropriate local, regional, state, or federal agencies

The functions of the Tucson Police Department include a plan to coordinate resources for the maintenance of public safety and welfare in the event of a major emergency or disaster. These tasks include but are not limited to:

- Law enforcement
- Search and rescue activities
- Enforcement of emergency orders designated by the Mayor of Tucson
- Emergency traffic control
- Security and perimeter control at incident scenes, shelters, staging areas, public health dispensing sites in the City, and the City of Tucson Emergency Operations Center, when needed
- Provide resources for warning, emergency information, and emergency evacuations

The Tucson Police Department will lead coordination efforts with other law enforcement agencies in the region during regional events. They will also participate in command structures to support other agencies that may have the lead for a major emergency.
