



## City of Tucson Dealer Trade Show Licensing

The Dealers-Trade show fee for each location, each dealer remains at \$28.00. However, in anticipation of the additional costs associated with the State of Arizona's new tax simplification law, Tucson's Mayor and Council established an **annual** municipal tax license fee of \$20.00 to be charged beginning in 2015 to businesses subject to transaction privilege tax requirements.

**Dealers/Vendors will pay \$48.00 and submit a City of Tucson municipal tax license application. A sales tax return will be issued to remit city sales taxes due on taxable revenues received during the show.**

The new municipal tax license is an annual fee. Dealers/Vendors who paid the combined \$48 license fee at the February show will only pay the \$28 dealer/trade license fee at the September show.

Please complete the City of Tucson municipal tax license application below. To minimize any disruption of business for vendors during the show, you may pay the fee and submit the application in advance. **The check in the amount of \$48.00 must be U.S. funds drawn from a U.S. bank.** Please mail to City of Tucson, Revenue Investigations, P O Box 27210, Tucson Arizona 85726-7210. **The deadline to mail the payment is December 31, 2014.** If you miss the mail-in deadline, there will be City Revenue Investigators attending all of the shows to collect the \$48.00 and the application. The Revenue Division staff looks forward to working together with you to make the licensing process as effortless as possible for all.
