City of Tucson Street Fair Licensing - 2015

The Street Fair fee for each event and each vendor remains at \$17.75. However, in anticipation of the additional costs associated with the State of Arizona's new tax simplification law, Tucson's Mayor and Council established an **annual** municipal tax license fee of \$20.00 to be charged beginning in 2015 to businesses subject to transaction privilege tax requirements.

Street Fair vendors will pay a total \$37.75 and submit a City of Tucson municipal tax license application. A sales tax return will be issued to remit city sales taxes due on taxable revenues received during the fair. The Fourth Avenue Merchants Association will be collecting the \$17.75 street fair fee and remitting it to the city. The City of Tucson will be collecting the municipal tax license fee from each vendor.

The new municipal tax license is an annual fee. Vendors who paid the \$20.00 tax license fee at the Spring fair will only pay the \$17.75 street fair fee at the Winter fair.

Please complete the City of Tucson municipal tax license application below. To minimize any disruption of business for vendors during the fair, you may pay the fee and submit the application in advance. **The check in the amount of \$20.00 must be U.S. funds drawn from a U.S. bank.** Please mail to City of Tucson, License Section, P. O. Box 27210, Tucson Arizona 85726-7210. **The deadline to mail the payment is February 27, 2015.** If you miss the mail-in deadline, there will be City Revenue Investigators attending the fair to collect the \$20.00 and the application. The Revenue Division staff looks forward to working together with you to make the licensing process as effortless as possible for all.
