

City of Tucson (COT) Requirements for the Sale or Storage of Permissible Consumer Fireworks.

PERMIT REQUIREMENTS:

- A Tucson Fire Department (TFD) “Sale or Storage of Permissible Consumer Fireworks (CFW) Permit is required for any location within the Tucson City Limits.
 - Any tent or temporary structure used for sale or storage of CFW, 400 sq. ft. or greater, requires a separate TFD Operational (tent) Permit at: TFD-Permit-Submittal@tucsonaz.gov .
 - An additional Permit may be required when fireworks are stored off-site. Contact the Tucson Fire Department (TFD) Fire Prevention Office at (520) 791-4502 for additional information.
 - A COT Business License, Peddler License or Temporary Use Permit may also be required. Contact City of Tucson Revenue Division located on the first floor of the City Hall Building at 255 W. Alameda Street (520-791-4566) for additional information.

STEPS TO ACQUIRE A CFW PERMIT:

Permit Applications and Plans may be submitted electronically (see below), or via Mail (provide return envelopes and postage) to: Tucson Fire Department, Attn: Permit Desk, 300 S. Fire Central Place, Tucson, Arizona, 85701.

Permit desk hours: M thru F, 8-11 am and 1-4 pm

- **Electronic Submittal:** You will find a downloadable [TUCSON FIRE CODE OPERATIONAL PERMIT APPLICATION](https://www.tucsonaz.gov/fire/permits-recalls-resources) at: <https://www.tucsonaz.gov/fire/permits-recalls-resources>. Once you have filled out the application, save to your computer and send (along with any other required items (IE. Site plans or CFW Material info) then attach/send them from that file location to: TFD-Permit-Submittal@tucsonaz.gov.
- After review, TFD will provide you a Permit Number and required fees (\$100) by email. You may pay with a Credit Card, Check or use you APA account at Tucson Fire Central, 300 S. Fire Central Place, Tucson, Arizona, 85701. **(SORRY, NO CASH IS ACCEPTED AT FIRE CENTRAL and NO PAYMENTS ON-LINE).**
- Pay fee for Tucson Fire Department (TFD) “Sale or Storage of Permissible Consumer Fireworks” Permit at City of Tucson Cashier location. Fee is payable to the *City of Tucson*.
- Retain the original permit application, which must remain “on-site”.

INSPECTION REQUIREMENTS:

- * **A TFD Fire Prevention inspection must be conducted prior to the sale of any Permissible Consumer Fireworks.** Please ensure accurate contact information on the application form.
- * **Contact Tucson Fire Prevention @ 520-791-4502 to schedule an inspection when tent is ready and product is on site; ready to put out.**
- * **The completed TFD CFW Application form must remain on-site.**
