Waiver of Subrogation. Policy shall be endorsed to include a Waiver of Subrogation endorsement in favor of the City of Tucson (including Worker's Compensation).

****NOTE:** Specific date(s) and location(s) of the event, to include set up and take down, must be clearly stated on the Certificate. Certificates shall be received no less than ten (10) working days prior to the event.
