Permit Waiver and Facility Rental Online Agreement Waiver

I understand that upon payment of charges and my acceptance of this permit for use that I, as the Permit Holder, am bound to comply with the following terms and conditions:

- This permit must be in the permit holder's possession during the scheduled purpose of use.
- Beer permits are not transferable or replaceable if lost or stolen. Replacement beer permits are at full purchase price.
- Glass containers are prohibited in City Facilities.
- The availability of electrical power is not guaranteed due to outlets overloading, malfunctioning, or vandalism.
- For reservations, cancel/change, or to report problems during business hours, call 791-4873. To report any problems after business hours, call 791-4144. Parking in undesignated areas and/or driving on unpaved areas to load or unload, including jumping castles, is prohibited per Tucson City Code Sec. 21-3(4)(3) and is subject to a fine.
- Permit holder is responsible for cleaning up the area of use at the conclusion of the rental. Failure to clean-up may result in a cleaning deposit for future use. Damage and/or litter to park facilities may jeopardize the right to make future reservations. First offense: user is notified of a \$50.00 maintenance deposit required on next reservation. Second offense: user loses \$50 deposit and is informed the next deposit will be \$100.00. Third offense: user loses deposit and future reservation privileges.
