I have attached the "Brentwood Development Project Information Sheet" which was the only informational document provided to the public during the neighborhood canvassing. It in no way describes or attempts to represent "the desires of the people who live close to this project", only Brentwood's description of the project.

Our canvaser was an extremely nice young woman professionally trained in respectful communication accompanied by two trained assistants. She was directed only to canvas, provide the information sheet and gather signatures from those who support the development, and specifically not to attempt to persuade anyone. If an individual expressed support they were then offered the option to add their signature to a form or a sample letter. If there is anyone who was intimidated, we would appreciate receiving information defining who they are by name and/or address and what was said that intimidated them so we can address that.
