- 2) Individuals wishing to speak during the hearing may join the hearing via teleconference and should submit a written request to PlanningCommission@tucsonaz.gov. Written request should be received by no later than 5:00 pm Tuesday, June 16, 2020. The email should include the Planning Commission public hearing date, your name, and, if you are calling in, the phone number you will use for the teleconference. The phone number provided will be used to identify the individual when/if being called upon to speak during the public hearing by the Planning Commission. Individuals wishing to speak but who did not submit a prior written request will be provided instructions by the Planning Commission at the time of the hearing on how to provide comments.

You may speak in favor or in opposition to the plan amendment during the public hearing.
