Subject: C8-16-04 Auto Wash Conveyor Text Amendment to the Unified Development Code (City Wide)

Issue – This is a public hearing to allow the Planning Commission to deliberate on the proposed amendment to the use specific standards restricting auto washing conveyors within the C-1 zone, as initiated by Mayor and Council on June 21st, 2016. With advancements in technology, the noise generated by conveyors now has little to no effect on surrounding properties (see attached noise study). The proposed Unified Development Code (UDC) text amendment will not result in a more or less restrictive change to how the requirements are implemented or enforced, all auto washing facilities in the C-1 zone will still be required to go through the Zoning Examiner Special Exception process.

The intent of this public hearing is to allow the Planning Commission to hear public input and deliberate on the proposed amendments (Attachment B).

Recommendation – Staff recommends that the Planning Commission recommend approval of the proposed amendments to the Unified Development Code (UDC), regarding auto wash conveyor's within the C-1 zone, to Mayor and Council.

Background – Beginning in 2014, the owner of an auto wash at the southeast corner of 12th Avenue and Drexel Road sent a letter to Planning and Development Services, requesting a modification of UDC Section 4.9.4.F.5 to remove the restriction on conveyors within the C-1 zone. It was determined at that time, there was insufficient evidence to demonstrate the impact on surrounding areas. On March 31, 2016, Staff met with representatives of the same auto wash facility, regarding this restriction within the C-1 zone and suggested the representatives provide evidence of the amount of sound generated by the conveyor through a sound study showing its potential impact on surrounding properties. That sound study was conducted and submitted to Staff showing little to no effect on surrounding properties (see attached noise study). Staff has reviewed this study and concurs with its findings.

On June 21, 2016, staff presented to Mayor and Council at a study session outlining the text amendments to the UDC, related to allowing conveyors on auto wash facilities within the C-1 Zone. Mayor and Council directed staff to proceed with the text amendment process.

On July 20, 2016, staff presented the Auto Wash Conveyor Text Amendment to Planning Commission at a study session. Planning Commission set a public hearing date for the Auto

Wash Conveyor Text Amendment for August 17, 2016. The public hearing was then continued to the September 21, 2016 Planning Commission meeting due to a notification error. At the September 21, 2016 Planning Commission meeting, the item was continued due to lack of quorum (Commissioner Ench recused).

Present Considerations – Pursuant to the Mayor and Council’s direction, staff prepared the following draft amendment (see Attachment B for more details on proposed amendments):

1. Allowed use of auto wash conveyors in C-1 zone:

Goal: Allow use of auto washing conveyors within the C-1 zone to address recent advances in technology which mitigate noise impact.

Proposal: Currently, UDC use specific standards restrict auto washing conveyors within the C-1 zone. This UDC text amendment would amend the standards as outlined in UDC Section 4.9.4.F.5, to allow auto washing conveyors with proper mitigation addressed through the Zoning Examiner Special Exception (ZESE) process. The ZESE process includes notification of nearby property owners and neighborhood associations, public hearing, and decision by the Zoning Examiner.
