ANY BANNER(S) DISPLAYED MUST ADHERE TO THE FOLLOWING CITY OF TUCSON CODES. FAILURE TO COMPLY WITH ANY OF THESE CODES WILL BE CONSIDERED A CODE VIOLATION. CODE VIOLATIONS CAN INCUR COURT FINES OF UP TO \$2500.00 AND A ONE YEAR PROBATION

- A. ONLY ONE BANNER ALLOWED PER STREET FRONTAGE.
- B. NO BANNER(S) MAY EXCEED 90 SQUARE FEET,
- C. ALL FOUR (4) CORNERS OF THE BANNER(S) MUST BE SECURELY ATTACHED TO A WALL OF THE BUILDING.
- D. THE BANNER(S) CANNOT BLOCK EXITS.
- E. THE BANNER(S) CANNOT EXTEND ABOVE BUILDING WALL/FACADE.
- F. THE BANNER(S) CANNOT BE ATTACHED TO POLES, TREES, FENCES, GATES, PATIO WALLS, TENTS, VEHICLES OR ANY OBJECT OR SURFACE OTHER THAN THE WALL OF THE BUILDING.
- G. ALL BANNERS MUST HAVE A PERMIT.
- H. THE BANNER(S) MUST BE REMOVED WHEN THE PERMIT EXPIRES.
