Construction of rear addition with porch Full Review/Contributing Resource

- Design was previously approved, but since then time has elapsed and the
 design has changed enough that they are before the board again. The design
 from the front elevation has not changed at all street front remains the
 same. new addition will be built out of stucco and painted a color to
 compliment the brick.
- Designed has been approved by the plans review sub-committee, with a recommendation to call out wood windows, guest hose to be painted to match new addition

Hazelbaker motioned to approve drawings as presented on the condition that the drawings include a note that states all new doors and windows be wood construction and that the addition to the paint color be complimentary to the existing colors of the home.
