PUBLIC HIGHWAY AT-GRADE CROSSING AGREEMENT WITH UNION PACIFIC RAILROAD AT BILBY ROAD (WARD 5)

The City of Tucson Department of Transportation and Mobility (DTM) is proposing improvements to the atgrade railroad crossing of the Union Pacific Railroad Nogales Subdivision ("Railroad") at Bilby Road. In order to advance the project, The City must enter into a Public Highway At-Grade Crossing Agreement ("Agreement") with the Railroad. The Agreement grants additional rights to the City of Tucson to facilitate advancement of proposed crossing improvements within Railroad right-of-way.

PUBLIC HEARING – UPDATE TO THE CITY OF TUCSON'S MAJOR STREETS AND ROUTES PLAN (CITY WIDE)

This is a Public Hearing to take public comment and consider a proposed amendment to the Major Streets and Routes (MS&R) Plan and Map. This amendment will update the MS&R Map to reflect recommended adjustments to future right-of-way values and street classifications citywide. Additionally, this amendment will update textual references in the MS&R Plan, to bring the plan document into conformance with the related updates to the MS&R Map. The goal of this update is to better support infill development and align the MS&R Plan with Move Tucson and the City's Complete Streets policy. This amendment is being executed in conformance with Unified Development Code Section 3.6.

To ensure programmatic continuity and maintain existing commitments to the public, staff recommends proposed changes to the MS&R will not impact existing transportation programs with funding tied to street classification, such as Proposition 101, Proposition 411, or the Collector Street Program. For any future funding sources or initiatives, the most current street classifications will be used.
