1. The City Clerk of the City of Tucson has certified the results of the recount;
2. Kevin Dahl received a total of 3,296 votes;
3. Sadie Shaw received a total of 3,277 votes;
4. There were also 20 write-in votes; and,
5. The total votes cast was 6,593 votes.

IT IS ORDERED that Kevin Dahl is the democratic nominee for the office of Ward 3 council member.
