It was moved by Council Member Kozachik, duly seconded, and passed by roll call vote of 7 to 0, that Consent Agenda Items a – f be passed and adopted, and the proper action taken.

8. PUBLIC HEARING: BINGO LICENSE - CRAZY HORSE RV LLC (WARD 5) AUG23-22-225

Mayor Romero announced City Manager's Communication number 225, dated August 23, 2022, was received into and made part of the record. She also announced this was the time and place legally advertised for a public hearing on a request for a bingo license at Crazy Horse RV, LLC. She announced the public hearing was scheduled to last no more than one hour and speakers were limited to five-minute presentations.

Mayor Romero asked if anyone wished to speak regarding this license.

There was no one.

It was moved by Council Member Fimbres, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Romero asked the City Clerk to read Resolution 23500 by number and title only.

It was moved by Council Member Fimbres, duly seconded, and carried by a voice vote of 7 to 0, to approve the Bingo License request as submitted.

9. TUCSON CODE: (C8-22-03) UNIFIED DEVELOPMENT CODE (UDC) TEXT AMENDMENTS REQUIRING ELECTRIC VEHICLE (EV) READINESS IN CERTAIN NEW DEVELOPMENTS, INCLUDING MULTI-FAMILY RESIDENTIAL, OFFICE, COMMERCIAL AND LARGE-SCALE RETAIL (CONTINUED FROM THE MEETING OF JULY 12, 2022) (CITY WIDE) AUG23-22-230

Mayor Romero announced City Manager's Communication number 230, dated August 23, 2022, was received into and made part of the record. She asked the City Clerk to read Ordinance 11953 by number and title only.

Ordinance No. 11953 relating to Planning and Zoning; amending the Tucson Code, Chapter 23B, Unified Development Code, Sections 3.3, 7.4, and 11.4; establishing requirements for Electric Vehicle (EV) readiness in certain new residential and commercial developments, including multifamily residential, office, and certain commercial including large-scale retail developments; establishing parking reduction incentives to encourage EV Readiness; and setting an effective date.

Mayor Romero indicated that the City Manager's Office had a planned presentation regarding this item.

Michael Ortega, City Manager, advised that Timothy Thomure, Assistant City Manager, would be speaking on this.

Mr. Thomure explained that the presentation was a timeline of the overall discussion leading to the evening's item.

Mayor Romero thanked Mr. Thomure for his presentation and explained that the Public Hearing regarding this item had been closed during their previous meeting. She stated that she wanted to include a few thoughts on the item. She stated the need to taking action had been discussed in previous meetings. She noted there had been complaints regarding the speeds of government being "too slow". She recognized the speakers at this evening's call to the audience, and their pleas to act. She acknowledged the Council's desire in acting on the strategies that had been designed regarding those plans.

Council Member Cunningham stated there needed to be flexibility, because in some cases the businesses may opt to use an alternative charging method.

Council Member Lee asked Council Member Dahl if he was open to the flexibility mentioned by Council Member Cunningham.

Council Member Dahl stated he would be open for discussions in a year, after Mayor and Council saw how this version operated.

Council Member Kozachik asked Council Member Dahl to clarify what level of stations was he proposing.

Council Member Dahl responded whatever staff had available. He stated that he did not have the exact figures available at the time.

Council Member Kozachik stated that it was unclear to him as well. He asked for clarification from Mr. Thomure.

Mr. Thomure stated that he would address this, he also stated that Dan Bursuck, Planning and Development Services Department, was available to answer any questions.

Mr. Bursuck responded that the proposal called for level 2 charges (220).

Council Member Kozachik asked Council Member Dahl if he would agree to drop those to level 1, or at least allow it as an option.

Council Member Dahl responded saying his understanding of EV was not technical and suggested that Mayor and Council follow staff recommendations and revisit those questions within the year.

Council Member Kozachik asked Mr. Bursuck why staff would not allow installations of level 1 versus a level 2 charging station.

Mr. Bursuck responded their recommendations on using level 2 chargers were based solely on the speeds of charging, and a level 2 charged faster than a level 1, whereas level 1 charges did not provide a full charge and level 2 chargers would remain consistent with charging stations already in use.

Council Member Kozachik asked if docking stations already established as a level 1 would be grandfathered in.

Mr. Thomure responded that they would.

Council Member Kozachik stated there had been requests for EV stations be replaced at a 1 for 2 ratio of EV outlets. He asked if it was possible to place to outlets to meet the required 5% for retail.

Council Member Dahl stated he was not open to that, as retail stations needed the faster charging level 2. He stated the conduits and outlets does prepare for the future but did not meet the current needs.

Council Member Fimbres asked for an explanation of the monetary process for the proposal and how it impacted the Mayor and Council in making changes if necessary. Mr. Thomure responded those could vary quite a bit, but the costs of conduit was roughly \$22 to \$43 per linear foot to trench and adding the conduit. He also stated the general costs of a Level 2 station could be between \$500 and \$6,000 depending on the products. He went on to say it should be noted the costs to retrofitting and adding conduit to an existing site could be four times those costs if they were done at the site developments.

It was moved by Council Member Dahl, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Ordinance 11953.

Michael Rankin, City Attorney, clarified for the record stating this would incorporate an effective date of December 1, 2022.

10. ADJOURNMENT

Mayor Romero announced the next regularly scheduled meeting of the Mayor and Council would be held on Tuesday, September 13, 2022, at 5:30 p.m., in the Mayor and Council Chambers, City Hall, 255 West Alameda, Tueson, Arizona.
