

### Minutes of MAYOR AND COUNCIL Meeting

## 10. PUBLIC HEARING: ZONING (C14-21-01) STREET NAME REQUEST – EAST GARDEN STONE DRIVE, CITY MANAGER'S REPORT, ORDINANCE ADOPTION (WARD 5) JAN25-22-22

Mayor Romero announced City Manager's communication number 26, dated January 25, 2022, was received into and made part of the record. She said this was the time and place legally advertised for a public hearing for a public hearing to approve a new street name, East Garden Stone Drive to connect the Blackhawk Ranch subdivision with South Wilmot Road.

Mayor Romero announced the public hearing was scheduled to last for no more than one hour and speakers were limited to five-minute presentations. She asked if there was anyone wishing to speak on the item.

There was no one.

It was moved by Council Member Fimbres, duly seconded, and CARRIED by a voice vote of 7 to 0, to close the public hearing.

Mayor Romero asked the City Clerk to read Ordinance 11899 by number and title only.

Ordinance No. 11899 relating to Streets; approving new street name, " East Garden Stone Drive," as shown on the Final Plat; and setting an effective date.

It was moved by Council Member Fimbres, duly seconded, and PASSED by a roll call vote of 7 to 0, to pass and adopt Ordinance 11899.

## 11. ZONING: (C9-21-01) BLACKHAWK – WILMOT AND I-10, SH AND C-2 TO R-1, ORDINANCE ADOPTION (WARD 5) JAN25-22-23

Mayor Romero announced City Manager's communication number 23, dated January 25, 2022, was received into and made part of the record. She said this request to rezone vacant, undeveloped land located on the south side of I-10, west of Wilmot Road and east of the Los Reales Landfill. The preliminary development plan proposes a 310-unit single-family residential subdivision at a density of approximately 3.6 units per acre and approximately 1.97 acres of functional open space.

Mayor Romero asked if the applicant or representative were present and agreeable to the proposed requirements.

Paul Oland, Paradigm Land Design LLC, on behalf of the property owner stated they were agreeable to the proposed requirements.

Mayor Romero asked the City Clerk to Read Ordinance 11901 by number and title only.

Ordinance No. 11901 relating to Zoning: amending zoning district boundaries in the area located on the south side of I-10, west of Wilmot Road and east of the Los Reales Landfill in case C9-21-01, Blackhawk - Wilmot and I-10, SH and C-2 to R-1; and setting an effective date.

It was moved by Council Member Fimbres, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Ordinance 11901.

## 12. ECONOMIC DEVELOPMENT: NOTICE OF INTENT TO ENTER INTO A DEVELOPMENT AGREEMENT WITH PROJECT PENNY (WARD 5) JAN25-22-24

Mayor Romero announced City Manager's communication number 24, dated January 25, 2022, was received into and made part of the record. She said the City Clerk to read Resolution 23434 by number and title only.

Resolution No. 23434 Relating to Economic Development; Approving a Notice of Intent to Enter Into a Tax Incentive Development Agreement (Agreement) with Project Penny ("Project Penny") for a Proposed Airplane Maintenance Hanger at Tucson International Airport; Making Certain Findings with Respect to that Agreement; and Adopting an Independent Economic Analysis Relating to the Agreement.

It was moved by Council Member Fimbres, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Resolution 23434.

Mayor Romero announced City Manager's communication number 25, dated January 25, 2022, was received into and made part of the record. She said the City Clerk to read Ordinance 11900 by number and title only

Ordinance No. 11900 Relating to The City Clerk; Appointing The City Clerk of The City of Tucson; and Declaring an Emergency.

Council Member Fimbres thanked Roger W. Randolph, City Clerk, for all of his years of service to the City of Tucson. He continued saying that the City Clerk's Office was a very important office that provided legislative information, clerical and logistical support to the Mayor and Council as well as provide administrative records management throughout the City and was responsible for City elections. He said Mr. Randolph's successor was someone who had been with the Clerk's Office for a number of years and was very knowledgeable of the position, which made it an easy transition.

It was moved by Council Member Fimbres, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Ordinance 11900, naming Suzanne Mesich as City Clerk.
