8. PUBLIC HEARING: APPROVING THE CITY OF TUCSON FISCAL YEAR 2023 ANNUAL ACTION PLAN – PROGRAM YEAR THREE OF THE FIVE YEAR CONSOLIDATED PLAN FISCAL YEAR 2020-2024 (CITY WIDE) MAY03-22-119

May or Romero announced City Manager's communication number 119, dated May 3, 2022, was received into and made part of the record. She said this is the time and place legally advertised for a public hearing on the City of Tucson draft FY 2023 Annual Action Plan. She announced the public hearing was scheduled to last for no more than one hour and speakers were limited to five-minute presentations. She asked if there was anyone wishing to speak on the item.

There was no one.

It was moved by Council Member Cunningham, duly seconded, and carried by a voice vote of 6 to 0 (Council Member Lee absent/excused), to close the public hearing.

Mayor Romero asked the City Clerk to read Resolution 23462 by number and title only.

Resolution No. 23462 relating to Public Housing; approving the proposed City of Tucson (City) Annual Action Plan Program year two of the five year consolidated plan for Fiscal Year 2023; authorizing and directing submittal of that plan to the United States Department of Housing and Urban Development (HUD); and declaring an emergency.

It was moved by Council Member Kozachik, duly seconded, and passed by a roll call vote of 6 to 0 (Council Member Lee absent/ excused), to pass and adopt Resolution 23462.

9. ZONING: (C9-21-17) BRAKE MASTERS – GRANT ROAD, C-1 TO C-2, ORDINANCE ADOPTION (WARD 6) MAY03-22-127

Mayor Romero announced City Manager's communication number 127, dated May 3, 2022, was received into and made part of the record. She said the request was to rezone property located on the south side of Grant Road, approximately 200 feet west of Swan Road. The preliminary development package (PDP) proposes demolition of a former vehicle inspection facility, and construction of a new auto service repair structure, with use classified as automotive service and repair—major.

Mayor Romero asked if the applicant or representative were present and agreeable to the proposed requirements.

Jim Egan on behalf of the property owner, Heights Properties LLP, was present and stated they were agreeable to the proposed requirements.

Mayor Romero asked the City Clerk to read Ordinance 11928 by number and title only.

Ordinance No. 11928 relating to Zoning: amending zoning district boundaries in the area located on the south side of Grant Road, approximately 200 feet west of Swan Road in case C9-21-17, Brake - Masters - Grant Road, C-1 to C-2; and setting an effective date.

It was moved by Council Member Kozachik, duly seconded, and passed by a roll call vote of 6 to 0 (Council Member Lee absent/ excused), to approve the request for rezoning as recommended by the Zoning Examiner and pass and adopt Ordinance 11928.

It was moved by Council Member Kozachik, duly seconded, and carried by a voice vote of 6 to 0 (Council Member Lee absent/ excused), to approve the City Manager's recommendation and rename the Tucson Convention Center Exterior Plaza Area to the Alva B. Torres Plaza.

12. PARKS AND RECREATION: RENAMING PUBLIC REQUEST OF THE TUCSON CONVENTION CENTER MUSIC HALL TO LINDA RONSTADT MUSIC HALL (WARD 6) MAY03-22-121

Mayor Romero announced City Manager's communication number 121, dated May 3, 2022, was received into and made part of the record.

It was moved by Council Member Kozachik, duly seconded, and carried by a voice vote of 6 to 0 (Council Member Lee absent/ excused), to approve the City Manager's recommendation and rename the Tucson Convention Center Music Hall to the Linda Ronstadt Music Hall.
