12. ZONING: (C15-22-01) ESTABLISHING ORIGINAL CITY ZONING AND EXTENSION OF MAJOR STREETS AND ROUTES DESIGNATION FOR THE AIRPARK 10 ANNEXATION DISTRICT, PIMA COUNTY CI-2 TO CITY OF TUCSON I-2, ORDINANCE ADOPTION (WARD 5) MAY19-22-135

She said this was a request to establish Original City Zoning within the Airpark 10 Annexation District. The district includes the parcels located at the corner of the south side of Los Reales Road and the east side of Alvernon Way. She said the Zoning Examiner recommends adoption of Original City Zoning of the City I-2 zone, and the extension of the Major Streets and Routes designation.

Mayor Romero announced City Manager's communication number 136, dated May 19, 2022, was received into and made part of the record. She said this was a request to establish special exception land use with BioLife Plasma Facility. The property is located on the south side of Auto Mall Drive, west of Oracle Road in the C-3 zone. She said the Zoning Examiner recommends approval of the special exception land use request for a plasma donor facility.
