Mike Rankin, City Attorney, announced he had a correction he needed to read into the record for Consent Agenda Item b. Section 2.9 of the Rules and Regulations the following verbiage was added to the changes already noted in the section, "A person shall be deemed a candidate for office on the filing of a nomination paper pursuant to A.R.S. § 16-311, subsection A, but not making a formal declaration of candidacy for that office."

It was moved by Council Member Fimbres, duly seconded, and passed by a voice vote of 6 to 0 (Council Member Dahl absent/excused), that Consent Agenda Items a through h, with the correction to Item b and the exception of Item i, which was considered separately, be passed and adopted and the proper action taken.

7. CONSENT AGENDA – ITEMS I

i. RESOLUTION: SUPPORTING THE NAMING OF THE INTERSTATE 10 OVERPASS AT RUTHRAUFF ROAD AS THE "STATE TROOPER JUAN CRUZ MEMORIAL OVERPASS" (OUTSIDE CITY) SEP13-22-240

Resolution No. 23508 relating to streets; authorizing and approving naming the Interstate 10 (I-10) Ruthrauff Road Overpass the "State Trooper Juan Cruz Memorial Overpass," and declaring an emergency.

Suzanne Mesich, City Clerk, announced the item to be considered separately was Consent Agenda Item i at the request of Council Member Fimbres.

Council Member Fimbres stated on December 9th, 1998, Department of Public Safety Officer Juan Cruz was killed in the line of duty on I-10 at Ruthrauff and whose name was now been selected for the naming of the Arizona Department of Transportation Overpass. The County Board of Supervisors as well as City of Tucson Mayor and Council, has been asked to weigh in on the petition which has over 7000 names and support. The Board of Supervisors voted to approve the proposal at their September 6th meeting, this agenda item does not cost city taxpayers money to say the City of Tucson supports the effort to name the I-10 and to recognized Officer Cruz for his work, his family and legacy. I moved that we approve consent item i.

Mayor Romero announced she was happy to support the request.

It was moved by Council Member Fimbres, duly seconded, and passed by a voice vote of 6 to 0 (Council Member Dahl absent/excused), that Consent Agenda Item i, be passed and adopted and the proper action taken.

8. ZONING: (C9-21-03) CASAS DEL CERRITO – PORTIA AVENUE, SR TO R-1, ORDINANCE ADOPTION (WARD 4) SEP13-22-243

Mayor Romero announced City Manager's communication number 243, dated September 13, 2022, was received into and made part of the record. This is a request to rezone approximately 9.65 acres from SR to R-1 zoning for the development of a residential subdivision on a vacant parcel located between Portia Avenue and Bonanza Avenue, east of Harrison Rd. The preliminary development plan (PDP) proposes a subdivision with forty-nine (49) single-family homes and provides 0.3 acres of functional open space. The project will be limited to single-story homes, with a maximum height of 19 feet.

Mayor Romero asked if the applicant was present and agreeable to the proposed requirements.

Paul Oland, Paradigm Land, representing the property owner and the developer, affirmed they were in agreement with the proposed requirements.

Council Member Lee said she wanted to thank the representatives and neighbors within the Old Spanish Trail Neighborhood Association, Tucson Unified School District and TK development for continuing to work together with my team. The development plans have come a long way since 2020, mitigating the many concerns from the residents, including lowering the height of the land. Limiting houses to single story, adding traffic mitigation measures, enhancing the functional open space and providing additional screening and privacy to the existing residents. Casas del Cerrito would not only help increase our housing inventory at a price point that was needed for our Tucsonans, but the

sale of the property would go directly towards USD capital investments and paying down the districts bond debt as approved by the voters.

It was moved by Council Member Lee, duly seconded, to pass Ordinance 11652.

Mayor Romero asked the City Clerk to read Ordinance <u>11652</u> by number and title only.

Ordinance No. 11955 relating to Zoning: amending zoning district boundaries in the area located between Portia Avenue and Bonanza Avenue, approximately ½ mile south of Golf Links Road and ¼ mile east of Harrison Road in case C9-21-03, Casas del Cerrito – Portia Avenue, SR to R-1 and setting an effective date.

Ordinance 11955 was passed and adopted by a roll call vote of 6 to 0 (Council Member Dahl absent/excused).

9. ZONING: (C9-22-04) ST. MARY'S AND SILVERBELL, R-2 TO C-1, CITY MANAGER'S REPORT (WARD 1) SEP13-22-244

Mayor Romero announced City Manager's communication number 244, dated September 13, 2022, was received into and made part of the record. This is a request to rezone an approximately 0.9-acre parcel from R-2 to C-1 zoning to construct a drive through coffee shop/restaurant with outside seating. The rezoning site is located at the northwest corner of the intersection of N Silverbell Road and W St. Mary's Road. Staff recommends authorization of C-1 zoning subject to certain conditions. The Zoning Examiner recommends authorization of C-1 zoning subject to the recommended conditions

Mayor Romero asked if the applicant was present and agreeable to the proposed requirements.

Rory Juneman, Lazarus & Silvyn, representing the property owner, affirmed they were in agreement with the proposed requirements.

It was moved by Vice Mayor Santa Cruz, duly seconded, and passed by a voice vote of 6 to 0 (Council Member Dahl absent/excused), to approve the request for rezoning as recommended by the Zoning Examiner.

10. CITY MANAGER: AMENDMENT NO. 4 TO EMPLOYMENT AGREEMENT (CITY WIDE) SEP13-22-246

Mayor Romero announced City Manager's communication number 246, dated September 13, 2022, was received into and made part of the record. She asked the City Clerk to read Ordinance 11957 by number and title only.
