The Mayor and Council of the City of Tucson met in regular session in the Mayor and Council Chambers in City Hall, 255 West Alameda Street, Tucson, Arizona, at 5:39 p.m., on Tuesday, August 22, 2023, all members having been notified of the time and place thereof.

Mayor Romero asked the City Manager to comment on the 22nd Street Bridge redesign.

Michael Ortega, City Manager stated that he would propose to reach out to the constituents who spoke regarding the 22nd Street redesign. He also spoke with Sam Credio of Transportation and the constituents to outline the situation that they have and solicit thoughts and ideas. He said that it was important to keep in mind that this project has been ongoing for several years, maybe even a couple of decades. All possible concerns or issues that people might have had were discussed over time, and the evolution of the conversation was evident to everyone, including the Mayor and Council. The next step was to bring back options and discuss them thoroughly.

Mayor Romero asked if they would be getting the information from the speakers and then convening.

Mr. Ortega stated yes and that he would call a meeting and would convene folks to have a conversation and have transportation folks there as well as his office.

Suzanne Mesich, City Clerk, made an announcement that the speaker cards did not have contact information, she stated that she had staff at the back of the room available to take their information if they would like to be contacted.

Mayor Romero stated to the audience that those who wished to be included in the convening regarding the 22nd Street redesign, please give your information to the city clerk staff.

Mayor Romero announced the reports and recommendations from the City Manager on the Consent Agenda were received and made part of the record. She asked the City Clerk to read the Consent Agenda.

Resolution No. 23661 relating to Intergovernmental Agreements (IGA); approving and authorizing execution of an IGA between Pima County (County) and the City of Tucson (City) to provide for the operation of a low-barrier shelter for unhoused individuals and families at the Knights Inn property; and declaring an emergency.

Mike Rankin, City Attorney stated to the Members of the Council that the Mayor had raised the issue of making sure that as part of this program and this project since there was a significant city investment in it, any materials that go out either advertising or giving notice of this program include recognition of the City of Tucson's participation in that through the use of the city logo, et cetera. They would contact Pima County and they would be happy to memorialize that agreement, once it was approved it would include that action as part of it.

Mayor Romero stated that it was worth mentioning the partnership between Pima County and the City of Tucson at Knights Inn. In partnership with Pima County, they were pooling together \$1.4 million of Home American Rescue Plan funds. The project received \$1.3 million from a grant from the Arizona Department of Housing, and \$1.6 million from

the City of Tucson and CDBG funds. Tucson residents would be able to prevent eviction and avoid homelessness thanks to the partnership between the City of Tucson and Pima County. The City of Tucson and Pima County worked together to create the Emergency Eviction Legal Services program that prevents homelessness in our community, and she would like to thank Pima County for their partnership and wanted to take a moment to thank Pima County for their partnership. Our residents would reap the benefits of this partnership at the Knights Inn.

It was moved by Council Member Lee, duly seconded, and passed by a roll call vote of 7 to 0, that Consent Agenda Items A-I, with the exception of Items b and f, which were continued, be passed and adopted and the proper action taken.

Mayor Romero announced at the request of Council Member Fimbres they were going to consider items 12 and 13.

12. ECONOMIC INITIATIVES: APPROVAL OF SALES TAX DEVELOPMENT AGREEMENT FOR HOME DEPOT (WARD 4)

(NOTE: This item was taken out of order.)

Mayor Romero announced City Manager's communication number 255, dated August 22, 2023, was received, and made part of the record. She asked the City Clerk to read Resolution No. 23659 by number and title only.

Resolution No. 23659 relating to Economic Development; approving a Notice of Intent to enter into a Tax Incentive Development Agreement (Agreement) with Home Depot for a new Retail Store in the Houghton Town Center; making certain findings with respect to that Agreement; and adopting an Independent Economic Analysis relating to the agreement.

Council Member Lee stated that she knew staff were able to share a lot of the statistics that were in the analysis and as you all know, per that analysis Home Depot was going to be a major sales tax anchor. That was exactly what the development needed to incentivize additional medium-sized anchor stores to invest in complete phases 2 and 3 over at the Houghton Town Center. She explained that the Independent Economic Analysis stated that

the estimated value of the incentive to the company was \$2.6 million, and over the next five years, this project was expected to generate direct revenue to the city of \$8.6 million and more than \$21 million in five years to other taxing jurisdictions within the region.

It was moved by Council Member Lee, duly seconded, to pass and adopt Resolution 23659.

Mike Rankin, City Attorney said for a quick housekeeping matter after items that were on the study session to allow for some discussion of these projects moving forward and known as normal practices, the Mayor and Council act in the study session to approve and move forward with the development agreement. He said that in the regular session to approve the notice of intent, but as the mayor had inquired during the study session, they could do both of those tonight because it was on the agenda. He stated by virtue of the motion, they would be able to approve the notice of intent through the resolution and give the direction to move forward with the development agreement, which would come back at a later time.

The motion was passed by a roll call vote of 7 to 0, to pass and adopt Resolution 23659.

13. ECONOMIC INITIATIVES: APPROVAL OF SALES TAX INCENTIVE AGREEMENT WITH PROJECT RITA (WARD 5) AUG22-23-254

Mayor Romero announced City Manager's communication number 255, dated August 22, 2023, was received, and made part of the record. She asked the City Clerk to read Resolution No._23658 by number and title only.

Resolution No. 23658 relating to Economic Development; approving a Notice of Intent to enter into a Tax Incentive Development Agreement (Agreement) with Project Rita for a new retail store at The Bridges; making certain findings with respect to that Agreement; and adopting an Independent Economic Analysis relating to the Agreement.

It was moved by Council Member Fimbres, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Resolution 23658.

Council Member Fimbres spoke about the anticipated contracting impact of Project Rita, which was projected to be \$30.3 million for the City of Tucson. The project was expected to generate an annual economy of \$15.7 million, with a total of \$78.5 million over the course of five years of operation, assuming the continued operation of both project components in the future.

8. PUBLIC HEARING: ZONING: (C9-22-02) TUCSON MOUNTAIN RV PARK, PAD - AJO WAY, R-1 TO PAD, ORDINANCE ADOPTION (WARD 1)

9. PUBLIC HEARING: ZONING: (TP-ENT-0223-00012), BROADWAY/ROSEMONT APTS. - BROADWAY BLVD. R-1 AND C-1 TO OCR-1, CITY MANAGER'S REPORT (WARD 6)

Mayor Romero announced Planning and Development Services Department Director was in attendance and wanted to address this item.

Kristina Swallow, Planning and Development Services Department (PDSD) Director read into the record a statement from Tom Warne, Applicant, regarding his request to withdraw the application. She said Mr. Warne complimented PDSD and the other city departments involved for their exemplary work on the rezoning process. He said that PDSD and other city departments were extremely thorough and efficient in researching the seven-acre site related to the Broadway Craycroft plan adopted by the Mayor and Council in September 1988, along with the goals and parameters of Plan Tucson as they related to the subject property. PDSD also answered many questions from various stakeholders as the process moved forward.

Ms. Swallow continued that Mr. Warne said the City moved each rezoning step along as quickly as possible within State and City regulations as soon as they received the necessary information from the developer and the results of the various rezoning components. Furthermore, the Ward 6 Office was very responsible and prompt in scheduling the three neighborhood meetings at the Ward 6 Office. They also facilitated dialogue throughout the process, as was requested.

Mr. Warne stated that everyone knew there was controversy relative to the rezoning, but the rezoning process went forward within the established rezoning guidelines. He said he was appreciative of Mayor Romero for the engagement of her staff, support for this project, and work to increase the housing inventory in Tucson. Unfortunately, the Waypoint Residential group had chosen to withdraw from the 222 gated apartment project at Broadway and Rosemont. The sole reason for their withdrawal was economic, specifically higher interest rates and higher construction costs. He wished to restate that there was no other reason, as they found the site extremely desirable and very much wanted to develop the 222 apartments to augment the adjacent 1.5 million square feet of office space and the 340,000 square feet of retail, all within walking distance, in addition to the excellent mass transit service on Broadway. He thanked everyone for their professionalism and the efforts that went into this rezoning process.

Mayor Romero expressed her appreciation for Mr. Tom Warne's idea and acknowledged everyone who contributed, including the neighborhoods, the Ward 6 Council office, his department, and the zoning exam. However, economic challenges may impede further progress on this project.

10. ZONING: (TP-MOD-0423-000009) PRINCE 10 PAD - MAJOR CHANGE, O-3 TO PAD-43, ORDINANCE ADOPTION (WARD 3)

Mayor Romero announced City Manager's communication number 258, dated August 22, 2023, was received, and made part of the record. She asked the City Clerk to read Ordinance 12027 by number and title only.

Ordinance No. 12027 relating to Zoning: amending Zoning District Boundaries in the area located at 2070 W Fort Lowell (former location of the Tra-Tel Tucson RV Park), approximately 560 feet west of the intersection of W Fort Lowell Road and N Business Center Drive just west of Interstate-10 between Prince Road and Miracle Mile in case TP-MOD-0423-000009, Prince 10 Planned Area Development – Major Change, O-3 To PAD-43 and setting an effective date.

Council Member Dahl stated that this project was in his ward and he and his staff visited a few weeks ago. The project had been in the works for a while and was approved by his predecessor, the Mayor, and the Council. Tonight, they were being asked to approve amendments to the project's boundaries. He was grateful to Gary Brav, the owner and developer, and Adam Call from the Planning Center for agreeing to increase the amount of water harvesting from what was originally approved. They have also agreed to additional measures that would supplement on-site landscaping with stormwater, which would improve the project's aesthetics. Furthermore, he appreciated that the project would create access to the Santa Cruz River Park for people.

It was moved by Council Member Dahl, duly seconded, and passed by a roll call vote of 6 to 0 (Council Member Fimbres absent/excused), to approve the request for Special Exception as recommended by the Zoning Examiner and pass and adopt Ordinance 12027.

Mayor Romero stated that she believed that Council Member Dahl presented an excellent opportunity for the City of Tucson. She said she was grateful to Gary Brov for his vision to revitalize an underutilized space. The project was complex, but Mr. Brov and his partners were committed to the best design and use for the area. She was eager to see the outcome of this development and would continue to contribute to the planned area development.

11. ZONING: (TP-ENT-0423-00019) W GRANT ROAD (C-2) (MARIJUANA DISPENSARY) SPECIAL EXCEPTION LAND USE, ORDINANCE ADOPTION (WARD 3)

Mayor Romero announced City Manager's communication number 257, dated August 22, 2023, was received, and made part of the record. She asked the City Clerk to read Ordinance 12026 by number and title only.

Ordinance No. 12026 relating to Zoning; a Special Exception Land Use – Marijuana Dispensary – TP-ENT-0423-00019 W Grant Rd – West Grant Road – located on the north side of Grant Road approximately 500 feet east of the intersection of N Oracle

Road and W Grant Road; approving with conditions the construction of a Marijuana Dispensary In the C-2 Zone; and setting an effective date.

Council Member Dahl stated that his office had received some concerns by email and during the call of the audience. He said that he would like to address those concerns, so he proposed and moved that they continue this item to the next regular Council Meeting to give his office enough time to take necessary actions and ensure that all concerns were addressed appropriately.

It was moved by Council Member Dahl, duly seconded, and passed by a roll call vote of 6 to 0 (Council Member Fimbres absent/excused), to not approve the request at this time for Special Exception as recommended by the Zoning Examiner and pass and adopt Ordinance 12027 and to continue to a future agenda.

12. ECONOMIC INITIATIVES: APPROVAL OF SALES TAX DEVELOPMENT AGREEMENT FOR HOME DEPOT (WARD 4) AUG22-23-255

It was moved by Council Member Cunningham, duly seconded, and passed by a roll call vote of 6 to 0 (Council Member Fimbres absent/excused), to pass and adopt Ordinance 12032, reappointing Karen Diebolt as Special City Magistrate for Tucson City Courts.

15. CITY MAGISTRATES: REAPPOINTMENT OF THADDEUS SEMON MAGISTRATE PRO TEMPORE FOR TUCSON CITY COURT (CITY WIDE)

Mayor Romero announced City Manager's communication number 266, dated August 22, 2023, was received, and made part of the record. She asked the City Clerk to read Ordinance 12033 by number and title only.

Ordinance No. 12033 relating to City Magistrates; reappointing Thaddeus Semon as full-time Magistrate Pro Tempore to serve upon call by the Presiding Magistrate of the City Court; fixing compensation; declaring this ordinance effective retroactively to February 21, 2023; and declaring an emergency.

It was moved by Council Member Cunningham, duly seconded, and passed by a roll call vote of 6 to 0 (Council Member Fimbres absent/excused), to pass and adopt Ordinance 12033 reappointing Thaddeus Semon as Magistrate Pro-Tempore for Tucson City Courts.

16. BOARDS, COMMITTEES AND COMMISSIONS: REAPPOINTMENT TO THE CIVIL SERVICE COMMISSION (CITY WIDE)

Mayor Romero announced City Manager's communication number 263, dated August 22, 2023, was received, and made part of the record. She asked the City Clerk to read Resolution 23663 by number and title only.
