Presentations were made by the following applicants for the Ward 5 Council Member vacancy: David Garcia, Gabriel Holguin, and Rocque Perez.


Discussion ensued, comments and questions were made Mayor Romero, Vice Mayor Santa Cruz, and Council Members Dahl, Lee, and Uhlich.




