**NOTICE OF BOND SPECIAL ELECTION TO BE HELD IN AND FOR THE  
CITY OF TUCSON, ARIZONA ON NOVEMBER 6, 2018**

TO THE QUALIFIED ELECTORS OF THE CITY OF TUCSON, ARIZONA:

A bond special election will be held on November 6, 2018.

The purpose of the election is to submit to the qualified electors of the City a question as to whether bonds of the City should be authorized to be issued in addition to all bonds authorized at previous elections.

The question to be submitted is as follows:

**Question No. 1**

**BONDS FOR PARKS AND RECREATION IMPROVEMENTS**

Shall the City of Tucson be authorized to issue and sell not exceeding \$225,000,000 principal amount of its general obligation bonds to provide funds for capital projects for parks and recreation, to wit: capital improvements to, and equipping of, existing parks; acquisition, construction, improvement, and equipping of new parks; acquisition, construction, improvement, and equipping of new and existing connectivity components between and within parks, including greenways, bikepaths, sidewalks, and walkways; and payment of all necessary costs and fees in connection therewith; such bonds to be issued in one or more series, maturing not more than forty (40) years from the date of issuance of each series, and bearing interest at a rate or rates not in excess of nine percent (9%) per annum?

A "yes" vote shall authorize the City of Tucson governing body to issue and sell \$225,000,000 of general obligation bonds of the City to be repaid with secondary property taxes.

A "no" vote shall not authorize the City of Tucson governing body to issue and sell such bonds of the City.

As required by A.R.S. § 35-454(C), the City gives notice that the issuance of these bonds will result in a property tax increase sufficient to pay the annual debt service on bonds.

The deadline to submit arguments for and against the bond proposal to the City Clerk is August 8, 2018.

The polls will open during the period from 6:00 A.M. to 7:00 P.M., inclusive, on the day of the election.

Any qualified elector may vote by early ballot in the manner provided by law. An official early ballot may be requested by telephone or mail from the Office of the Pima County Recorder, P.O. Box 3145, Tucson, AZ 85702-3145, telephone: (520) 724-4330; provided that such request is received by the Office of the Pima County Recorder no later than 5:00 p.m. on October 26, 2018. Any elector who appears personally no later than 5:00 p.m. on November 2, 2018 at an on-site early voting location established by the Pima County Recorder will be given a ballot and permitted to vote at the on-site location. .
