April 21, I submitted the below email asking you to support Pam Powers and vote for her to finish Steve Kozachik's term. I did not, however, say in my email who I did NOT feel was qualified to complete Steve's term and I feel compelled to do that now.

In my work as secretary for Garden District Neighborhood I know how critical the Ward VI office is to the well-being, safety, and quality of life of our residents. I read through the submissions of support on the City Clerk's site last night and was surprised and disturbed by the number of emails endorsing Miranda Schubert.

I now find myself at 2 am unable to sleep and am writing you to urge you NOT to include Miranda Schubert as one of your choices for the Ward VI councilperson.

I researched Miranda last night to see if her positions had changed since the last primary election where I and 2/3 of those voting did not vote for her. I found they had not. Miranda's stance and opinions on many topics conflicts with those of a large portion of Ward VI constituents. She also seems to have a narrow personal agenda that she is passionate about and I do not feel she understands the broad and diverse priorities and needs of the Ward VI constituency.

Also, I am concerned that she lacks adequate experience and knowledge about finance and budgets the size of the City of Tucson. I don't believe being on the board of her non-profit Roller Derby organization qualifies her to be a primary decision maker in a 2 billion dollar budget process. Many of the other candidates were more qualified.

Please do not include Miranda Schubert as one of your choices to complete Steve Kozachik's term.
