The following information must be submitted with the Affidavit of Appeal form:

Pursuant to Tucson Code Sec. 15-36, the Director shall determine whether a particular load is from a commercial hauler or residential self-hauler, and whether the load is securely covered or properly restrained. If the Director determines that you have overpaid, the excess fee charged will be reimbursed to you, or if you have an account with the Department, credited against amounts you owe the Department.

In addition to other sanctions/remedies, false statements on this Affidavit may result in prosecution under A.R.S. Title 13, Chapter 24 (Obstruction of Public Administration), Chapter 27 (Perjury and Related Offenses), or both.
