#### 12. CALL TO THE AUDIENCE

- a. Bill Katzel first wanted to thank the City staff for opening City Hall to the public without requiring a badge and security check. He also indicated that with Lt. Carrillo retiring and going to work for Ward 6, the Platinum Application for Bicycle Friendly Community needs a quality new appointment to take Lt. Carillo place. Mr. Katzel also requested that the Fantasy Island project be re-addressed by the new council.
- b. Michael Toney presented evidence of the violation of the MOU by the University of Arizona. According to the MOU there needed to be a joint agreement and M&C approval to move forward on any future UA Science Center project. He feels the planned development is too large to support the natural resources available.
- c. Rev. Servant Bishop Chicago expressed his concern about the waste that goes on in this country. He also feels that Tucson does not need more police as they cannot be handled now and they need to be held accountable. He also spoke in support of bus drivers and emergency responders, that they need to be appreciated.
- d. Bonnie Poulos, on behalf of the Neighborhood Infill Coalition, welcomed the new City Council Members and looks forward to working with City of Tucson staff and Council regarding infill issues.
- e. Victor Ferrara from 24/7 taxicab company announced a 3pm Wednesday Kickoff Rally for the Community Food Bank 3003 S. Country Club Rd. His company will pick up any food or check donations to the Community Food Bank for free until 12/24. Contributors will also receive a 10% discount card for a future cab ride. - f. Gretchen Wagenseller spoke out in support of the libraries, and would like to see more weekend hours for people who work during the week, as only 4 libraries have hours on Sunday. She requests staff review usage, pro-rate it by hour to see if more Sunday hour could be supported.
