Council Member Dunbar offered the following amendment to the motion regarding Environmental Services:

- 1. Establish a low-income protection program for garbage fee
- 2. Address special concerns of Mobile Home parks
- 3. Improve the management of Environmental Services as they transition into an Enterprise Department
- 4. Increase customer services for citizens, by tracking complaints and developing a two-year plan to reduce complaints.
- 5. Citizen Oversight of Environmental Services (similar to CWAC) and should include annual reports from ESAC to the Council on how well the enterprise is operating.
- 6. Return to the Council with a plan for a "Pay As You Throw" program within the next year, if not sooner.

Amendments to the motion regarding Environmental Services were accepted.

Council Member Dunbar offered additional amendments for the FY 2005 budget.

- Employee efficiency review report to council employees ideas on how to save money and make government more efficient – by December 2004
- 2. Hire an independent auditor to review city finances and report to council by December 2004
- 3. Report on opportunities to expand the Sun Tran and Van Tran advertising program with smaller side panels by December 2004
- 4. Staff should generate a report by October 2004, outlining a plan to share increases in health care benefits with employees and look at Tucson as compared to benchmark markets for 2006. This report should include comparisons with the Phoenix market and other local public employer
- 5. Report **next week** (off agenda) on the opportunity to prepare a November 2004 ballot referendum that would "uncap" or "raise the cap" of the property tax and present G.O. bond packages for Parks and Recreation, public safety, groundwater remediation and transportation infrastructure and possibly Revenue Bonds for Environmental Services.

 - 6. Begin discussions with Pima County and other jurisdictions on the future of the Library system **immediately**.
 - 7. Discuss with the County the formation of a joint city-county "Local Government Efficiency Task Force". This task force will work with the Citizens' Finance and Services committee to develop recommendations on efficiencies, departmental consolidations and other ideas to help local government become more regional in its focus and more efficient and cost-effective in its operations.
 - 8. Any last-minute ideas by council members or city staff to raise revenues that are reasonable and easy to implement should be brought to the council immediately following staff review.

Additional amendments to the motion for the FY 2005 budget were accepted.

Motion as amended PASSED by a 4 to 3 vote (Council Members Ibarra, Scott and Leal dissenting).

In addition to the formal motion, Council Member West offered the following suggestions:

- Improve operations of City by asking City employees what can be done to save money in their departments. To do this we must create a system and an environment that protects employees and at the same time encourages them to share their ideas,
- Establish an independent audit function, under the Mayor, to review City spending and show the public that there is a system in place to ensure their taxes are being spent appropriately.
- Change the budget process to not penalize departments who don't spend all of their allocation understanding some funds must be carried forward for grants or capital projects.
- Look at property tax cap and sales tax cap in the Charter. Continue to look for way to diversify revenues.

Additionally, in Solid Waste, consider changing over the next year or two:

- Move away from Saturday service and toward M-F collections
- Move away from Sunday landfill operation.
