re: Financial notification from a petition drive committee

Note: On December 13, 2016, on instructions from the city clerk's office, Strong Start Tucson (Id # 16-256-CT) terminated its status as a political committee in support of a ballot initiative and filed an initial registration as Strong Start Tucson, a political action committee (Id # 16-259-CT). At that time we were advised by the clerk's office that despite the termination of our status as a political committee in support of a ballot initiative, Tucson City Code 12-104 (b), pertaining to financial notification requirements for a petition drive political committee, had not been repealed and thus was potentially still applicable. It is not clear to Strong Start Tucson that the requirements in fact are applicable given the circumstances. The code section is also not clear concerning to what "cumulative" in this section refers given the timing of the termination and re-filing. Nevertheless, because Strong Start Tucson wishes to comply, we provide the following notification concerning receipts. This disclosure, of course, should not be read as a waiver of any ability to pursue arguments concerning the non-applicability of 12-104 given the unusual facts concerning Strong Start Tucson.
