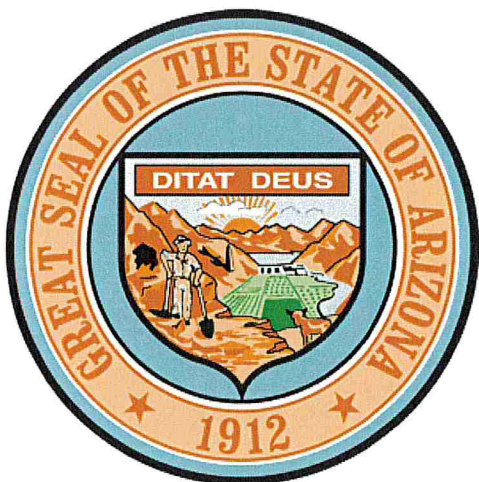

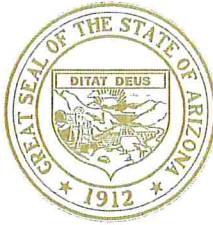

A standing committee may terminate its activities in a particular reporting jurisdiction (and remain active in other reporting jurisdictions) by filing a statement of that intent in each reporting jurisdiction. [A.R.S. §§ 16-901(48), -906(E), -928(B), -934(E)]
