

**2013 PRIMARY ELECTION CANDIDATES AND INITIATIVE PETITIONS IN
CIRCULATION**

The deadline for candidates to file nomination petitions for the August 27 Primary Election was May 29. Attached is the listing of candidates who filed petitions, along with two initiative petitions currently in circulation in the City of Tucson.

CITY EMPLOYEE E-MAIL

As a friendly reminder, all candidates, political parties and political committees should go through their e-mail lists and delete any to City of Tucson employees. The e-mail address ends in tucsonaz.gov.

Tucson Code 10-18 (D)(2) states: "No person shall, directly or indirectly, command, solicit or receive, or be concerned in soliciting or receiving, any such assessments, subscriptions, or contributions from officers or employees in the classified service during the hours they are required to be on duty."

Additionally, City of Tucson Administrative Directive 1.08-4 states: "City electronic communication systems shall not be used to transmit political messages, in behalf of or against a candidate for election or retention or in support of or opposition to an initiative, referendum or recall or any other measure or proposition, additional guidance may be found in the Political Activities Guidelines for Officers and Employees in the City of Tucson Classified Service."

Because of the provisions of our Administrative Directive, e-mail sent by political committees may expose City employees who respond by giving money or simply forwarding the e-mail to possible disciplinary action. Moreover, under the provisions of the Tucson Code, these types of e-mail are a violation of law and a misdemeanor.

Based on these provisions we request that you remove all City of Tucson e-mail addresses from your e-mail distribution lists. Violations could be deemed knowing and referred to the City Prosecutor to be reviewed for possible prosecution.
