From time to time, this office distributes information regarding campaign finance and other election related issues that may be of interest to you. We encourage you to contact the City Clerk's Office with any questions you have regarding these issues.

BALLOTS MAILED

General election ballots will be mailed beginning October 17 to all active voters in the City. Ballots must be received by the City Clerk by 7:00 PM on Election Day. We recommend dropping ballots in the mail by October 31st to ensure they are received in the City Clerk's Office on Election Day.

BALLOTS RETURNED REPORTS

The City Clerk's Office prepares Vote-by-Mail reports that can be purchased by campaigns. The information is provided on a CD. The **Ballot Requests** report is the list of voters who have been mailed a ballot for the General Election. The **Ballot Returns** report is the list of voters who have returned their ballot for the General Election.

- The **Ballot Requests** report will be available on October 18
- The daily **Ballot Returns** reports will be available starting October 24
- Pay for the reports using the attached form in person at the City Clerk's Office / City Hall, 255 W. Alameda, 9th Floor, or by mail
- Pick up the reports (CDs) at the Tucson City Clerk Elections Center, 800 E. 12th Street
