2. INVOCATION AND PLEDGE OF ALLEGIANCE AND APPOINTMENTS TO BOARDS, COMMITTEES AND COMMISSIONS

It was moved by Council Member Scott, duly seconded, and passed by a roll call vote of 7 to 0, that Consent Agenda Items a - f be passed and adopted and the proper action taken.

8. PUBLIC HEARING: AMENDING (CHAPTER 23B) THE UNIFIED DEVELOPMENT CODE, RELATING TO PERMITTED USE TABLES AND GROUP DWELLING PARKING

Mayor Rothschild announced City Manager's communication number 184, dated June 5, 2018, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on the proposed text amendment revisions to various *Unified Development Code* regulations.

Mayor Rothschild said the public hearing was scheduled to last for no more than one hour and speakers were limited to five minute presentations. He asked if there was anyone wishing to speak on the item.

There was no one.

It was moved by Vice Mayor Cunningham, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Rothschild asked the City Clerk to read Ordinance <u>11557</u> by number and title only.

Ordinance No. <u>11557</u> relating to Planning and Zoning; amending the Tucson Code, Chapter 23B, Unified Development Code, Sections 4.8.3, 4.8.4, 4.8.6, 4.8.7, and 4.9.7; and setting an effective date.

It was moved by Council Member Fimbres, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Ordinance 11557.

Council Member Fimbres asked staff to further explain, in detail, why the need to clarify childcare with extended hours was listed. He also asked about the situations that had shown the need for proposed clarification of group dwelling parking regulations.

Daniel Bursuck, Planning and Development Services Lead Planner, stated during the translations from the *Land Use Code (LUC)* to the *Unified Development Code (UDC)*; there were certain errors in some of the zones that were not found in the initial translation. This was one, when they were reviewing a case that related to childcare, they realized the actual permitted portion was placed into a different zone on the zone table and the indication of this was that the use specific standards that were with it, indicated it was within the actual zones. He said it was just them going through it and making the corrections.

Mr. Bursuck stated for the group dwelling parking regulations, it was not entirely clear, so staff was reviewing the group dwelling parking requirements. They realized it stated the group dwelling parking allowed parking spaces on the side and back yards, but not specific about the front yards, and this clarified what type of parking spaces would be allowed in the front yard.

Ordinance 11557 was declared passed and adopted by a roll call vote of 7 to 0.

9. PUBLIC HEARING: TRUTH IN TAXATION HEARING FOR THE PRIMARY PROPERTY TAX; NOTICE OF PRIMARY PROPERTY TAX INCREASE

Mayor Rothschild announced City Manager's communication number 187, dated June 5, 2018, was received into and made part of the record. He also announced this was the time and place legally advertised for a Truth in Property Taxation public hearing.

Mayor Rothschild announced the public hearing was scheduled to last for no more than one hour and speakers were limited to five minute presentations. He asked if there was anyone wishing to speak on the item.

There was no one.

It was moved by Council Member Fimbres, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Rothschild announced the adoption of the primary and secondary property tax ordinances was scheduled for the Mayor and Council meeting of June 19, 2018.

10. PUBLIC HEARING: 2019 BUDGET AS TENTATIVELY ADOPTED ON MAY 22, 2018

Mayor Rothschild announced City Manager's communication number 188, dated June 5, 2018, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on the Budget as Tentatively adopted on May 22, 2018.

Mayor Rothschild announced the public hearing was scheduled to last for no more than one hour and speakers were limited to five minute presentations. He asked if there was anyone wishing to speak on the item.

There was no one.

It was moved by Vice Mayor Cunningham, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Rothschild announced the meeting was adjourned and they would convene a Special Meeting for the purpose of adopting the budget for Fiscal Year 2019.
