Mayor Rothschild announced City Manager's communication number 45, dated February 9, 2016, was received into and made part of the record. He said this was a request to establish Original City Zoning within the Limberlost and Fairview Annexation District, surrounding the intersection of Limberlost Drive and Fairview Avenue.

Mayor Rothschild said the Zoning Examiner and staff recommend approval of C-2, MU, O-3 and SH zoning and extension of the *Major Streets and Routes Plan* arterial street designation along Wetmore Road and collector street designation along Fairview Avenue within the Annexation District.

Mayor Rothschild asked the City Clerk to read Ordinance <u>11337</u> by number and title only.

Ordinance No. <u>11337</u> relating to zoning: establishing original City zoning surrounding the intersection of Limberlost Drive and Fairview Avenue in case C15-15-04, Limberlost and Fairview Annexation District, County CB-2, MU, TR, and SH to City C-2, MU, O-3 and SH and setting an effective date.

It was moved by Council Member Scott, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Ordinance <u>11337</u>.

9. ZONING: (SE-15-78) VERIZON – CRAYCROFT ROAD, SR ZONE, WIRELESS COMMUNICATIONS FACILITY, SPECIAL EXCEPTION LAND USE, ORDINANCE ADOPTION

Mayor Rothschild announced City Manager's communication number 46, dated February 9, 2016, was received into and made part of the record. He said this was a special exception land use request for property located 170 feet south of Rillito River Park and 520 feet west of Craycroft Road.

Mayor Rothschild said the Zoning Examiner and staff recommend approval of the special exception land use with conditions. He asked the applicant or representative was present and agreeable to the proposed requirements.

Adam Brixius, Pinnacle Consulting on behalf of Verizon Wireless, stated they were agreeable to the proposed requirements.

Mayor Rothschild asked the City Clerk to read Ordinance No. <u>11338</u> by number and title only.

Ordinance No. <u>11338</u> relating to Zoning; a special exception land use - Wireless Communications Facility - SE-15-78, Verizon - Craycroft Road located 170 feet south of Rillito River Park and 520 feet west of Craycroft Road; approving with conditions the construction of a wireless communication tower with twelve (12) antenna panels concealed within an artificial pine tree, 70 feet in height, within an approximately 852 square foot lease area in the SR zone; and setting an effective date.

It was moved by Council Member Cunningham, duly seconded, and passed by a roll call vote of 7 to 0, to approve the request as recommended and pass and adopt Ordinance <u>11338</u>.

10. ZONING: (SE-15-79) VERIZON – WEST SPEEDWAY BOULEVARD, C-1 ZONE, WIRELESS COMMUNICATIONS FACILITY, SPECIAL EXCEPTION LAND USE, ORDINANCE ADOPTION

Mayor Rothschild announced City Manager's communication number 47, dated February 9, 2016, was received into and made part of the record. He said this was a special exception land use request for property located 75 feet north of Speedway Boulevard and 225 feet east of Riverview Boulevard.

Mayor Rothschild said the Zoning Examiner and staff recommend approval of the special exception land use with conditions. He asked if the applicant or representative was present and if they were agreeable to the proposed requirements.

Michael Rankert, Techtonic Engineering on behalf of Verizon Wireless, stated they were agreeable to the proposed requirements.

Mayor Rothschild asked the City Clerk to read Ordinance <u>11339</u> by number and title only.

Ordinance No. <u>11339</u> relating to Zoning: a special exception land use - Wireless Communications Facility - SE-15-79, Verizon - West Speedway Boulevard located 75 feet north of Speedway Boulevard and 225 feet east of Riverview Boulevard; approving with conditions the construction of a wireless communication tower with twelve (12) antenna panels concealed within an artificial pine tree, 65 feet in height, within an approximately 1,225 square foot lease area in the C-1 zone; and setting an effective date.

It was moved by Council Member Romero, duly seconded, and passed by a roll call vote of 7 to 0, to approve the request as recommended and pass and adopt Ordinance 11339.

11. ZONING: (C9-05-29) DOS HOMBRES LLC – COLUMBUS BOULEVARD, R-1 TO R-2, ORDINANCE ADOPTION

Mayor Rothschild announced City Manager's communication number 49, dated February 9, 2016, was received into and made part of the record. He asked the City Clerk to read Ordinance 11341 by number and title only.

Ordinance No. <u>11341</u> relating to Zoning: amending zoning district boundaries in the area located at the Northwest corner of Columbus Boulevard and Blacklidge Drive in case C9-05-29, Dos Hombres LLC - Columbus Boulevard, R-1 to R-2; and setting an effective date.

Vice Mayor Uhlich said she wanted to note there were protests associated with the materials stating she appreciated the work done on the part of staff and the Zoning Examiner. She said in reviewing the materials she felt the density and design were compatible with the area. She commented she was familiar with the area; McCormick Park was across Columbus, there was open green space, the traffic patterns, and low use of Blacklidge Drive in the area. She said she felt the roadway could accommodate the additional development.

It was moved by Vice Mayor Uhlich, duly seconded, and passed by a roll call vote of 7 to 0, to approve the request as recommended and pass and adopt Ordinance 11341.

12. WATER: COMMEMORATIVE NAMING OF THE CENTRAL AVRA VALLEY STORAGE AND RECOVERY PROJECT (CAVSARP) SOLAR ARRAY (CONTINUED FROM THE MEETING OF JANUARY 5, 2016)

Mayor Rothschild announced City Manager's communication number 48, dated February 9, 2016, was received into and made part of the record. He asked the City Clerk to read Resolution <u>22515</u> by number and title only.

It was moved by Council Member Fimbres, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Resolution <u>22515</u>.

It was moved by Council Member Cunningham, duly seconded, and carried by a voice vote of 7 to 0, to approve the appointment of Dennis Coon and Jeff Hamstra to the Tucson-Pima County Joint Consolidated Code Committee and the reappointment of Ed Torres to the Veterans' Affairs Committee (VAC).

Mayor Rothschild asked if there were any personal appointments to be made.

Council Member Cunningham announced his appointment of Bruce Hermes to the Tucson-Pima County Bicycle Advisory Committee (BAC).
