7. CALL TO THE AUDIENCE

Mayor Walkup announced that this was the time any member of the public was allowed to address the mayor and council on any issue except for any items scheduled for a public hearing. Speakers would be limited to three-minute presentations. He said there were a number of speakers.

- a. Michael Toney, addressed the council regarding his interaction with the Rio Nuevo Board.
- b. Bill Katzel, addressed the mayor and council and urged their support for the expansion of Christopher Columbus Park.
- c. Dennis Stuart, thanked the mayor and council for their support of the arts.
- d. Allison Ackamis, a dancer and trapeze artist, also thanked the mayor and council for their support of the arts.
- e. Jamie Schremmer, addressed the mayor and council regarding the Greyhound Depot and commented that the design for the 4th Avenue underpass was too wide.
- f. C. J. Karamargin, urged the mayor and council to increase police patrol in the SAMOS neighborhood.
- g. Jerry D'Paco, addressed the mayor and council and commended the Tucson Police Department and Michelle Phillips of the Graffiti Abatement Program for swift action in his neighborhood.
- h. Robert Rues, addressed the mayor and council in opposition to any increase in garbage fees.

8. PUBLIC HEARING: TUCSON CODE (AMENDING CHAPTER 4) RELATING TO THE LICENSE FEE FOR UNALTERED DOGS)

Mayor Walkup announced that city manager's communication number 124, dated March 15, 2004, would be received into and made a part of the record. He also announced that this was the time and place legally advertised for a hearing on license fees for unaltered dogs. This was the second of two public hearings on this topic and that the first hearing was held on October 27, 2003.

Mayor Walkup announced that the public hearing was scheduled to last for no more than one hour and speakers would be limited to five-minute presentations. He had no speaker cards, so he opened the floor to anyone who wished to speak on this issue. He reminded the audience that this was the second public hearing and that those who had spoken at the first hearing should remain seated and let others make the official input. Comments made at the previous public hearing were recorded for the record. He asked that speakers give their name and address for the record.

Jamie Schremmer, said she was the owner of four dogs. The last one she picked up on the road a few weeks ago. She stated that people who license their dogs, license their dogs and people who don't, don't. She believed that \$75 was an outrageous amount to charge and it should be reduced. In addition, she believed that the recent charge for dropping off an animal at the pound had caused a lot of problems. There were dogs everywhere: dogs were being left in the parks and being left in the river and dogs were being left in the roadway and now there were dead dogs that the dog catchers would have to work more hours to clean up. She really had a problem with that fee. People should be able to just drop their dogs and cats off at the pound for free again.

She also said that dogs and cats that had periodontal disease were often unadoptable at the pound, because they were considered to have a medical illness. She had a problem with that because there have been dogs that she would have adopted until she found them homes, but couldn't because they needed dental care. She was shocked. Those animals would be put to death because they needed dental care. It was shocking. She thought that the pound does a good job and the humane society does a good job and FAIR and all the other groups that save animals do a good job.

It was moved by Council Member Dunbar, seconded by Council Member West, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Walkup up asked the city clerk to read ordinance 9942 by number and title only.

Ordinance No. 9942

Relating to Animals and Fowl; providing for a reduction in the license fee for unaltered dogs; amending the Tucson Code by amending Section 4-82; and declaring an emergency.

Mayor Walkup recognized Council Member Dunbar.

Council Member Dunbar said that it was in 1998 that they started working on this issue. The group worked with Council Member Anderson to find out what other communities were doing to stop the senseless killing of animals. Back in 1998, there were 11,518 dogs euthanatised in this community because there were not enough homes. The group realized that one thing that was working in other communities was to have a licensing differential. She understood that some people might think that the \$75 fee would be high, but they have had a 21 percent decrease in the number of dogs euthanatised in the last few years. They have also had a 35 percent increase in spays and neuters according to the Humane Society. She thought the numbers could have been better if the city and the county were on the same page.

Council Member Dunbar said that people have asked her why the public hearing was continued. It was because certain members of the Board of Supervisors had agreed that if the city would lower their fee, then the county would raise theirs. She respectfully asked that everyone vote for this item. She said it would be imperative that the county join the city and that they enforce licensing, because that would be the money that supported animal control. If you love your animals and you care about animals, then it would be imperative that animals are licensed, because that would be the revenue that would be funding animal control. She believed that they would have seen a lot higher number of spays and neuters and lower numbers in euthanatized animals had the city and the county been on the same page, had the county enforced licensing and had the county had the funding to do so. Part of the problem was that the city and the county budgets faced so many deficits so they did not have animal control officers to do the job.

It was moved by Council Member Dunbar, seconded by Council Member Leal, that ordinance <u>9942</u> be passed and adopted.

Relating to zoning: amending zoning district boundaries in the area located south of Golf Links Road between Camino Seco and the Pantano Wash in Case C9-02-17, Brown – Camino Seco Road, SR to R-1; and setting an effective date.

It was moved by Council Member Scott, seconded by Council Member West, that ordinance 9941 be passed and adopted.

Mayor Walkup asked if there was any discussion. There was none.

Council Member Dunbar announced her personal appointment of Benny White to the City Attorney Selection Committee.
