

# Minutes of MAYOR AND COUNCIL Meeting

Approved by Mayor and Council on May 10, 2005

Date of Meeting: April 5, 2005

The Mayor and Council of the City of Tucson met in regular session in the Mayor and Council Chambers in City Hall, 255 West Alameda Street, Tucson, Arizona, at 6:03 p.m. on Tuesday, April 5, 2005, all members having been notified of the time and place thereof.

### 1. ROLL CALL

The meeting was called to order by Vice Mayor Dunbar, Mayor Pro-Tempore, and upon roll call, those present and absent were:

#### 2. INVOCATION AND PLEDGE OF ALLEGIANCE

(Note: The Invocation and Pledge of Allegiance were taken out of order and conducted at the Public Housing Authority meeting, which was held at 5:30 p.m.)

### 11. CITY MAGISTRATES: APPOINTING A CITY MAGISTRATE

(Note: This item was taken out of order.)

Mayor Pro-Tempore Dunbar announced communication number 158, dated April 5, 2005 would be received into and made a part of the record. She stated there were a lot of people in the audience wanting to speak, but it was not a public hearing. To be fair, there would be two Commissioners speaking, Ms. Terrazas would speak, and two people on her behalf would speak. Mayor Pro-Tempore Dunbar stated the Council was having problems interpreting the report and asked Judge Riojas to give a presentation first.

Judge Antonio Riojas, Presiding Magistrate, said the Council had received statistical summaries of the Judicial Performance Review (JPR). This was based on an instrument used by the Arizona Supreme Court for judges throughout the state. Three groups of people were given surveys on each judge. These included the staff, attorneys, and litigants. Each person was asked to rank the judge on various items as superior, very good, satisfactory, poor, or unable to rate on a number of categories. Superior Court compiled the numbers the Council had seen. The survey results stated the number of returns for each category and the number of votes for each category.

Discussion ensued regarding the methodology used during the survey and the number of surveys received.

Council Member Scott asked if were there any documents presented to the City Magistrate Merit Selection Commission that the Council had not seen.

Judge Riojas stated the only documents he was aware of, in addition to the surveys, were from the people filling out the surveys who had a right to submit written comments. Those comments were given to the City Magistrate Merit Selection Commission. As part of the modification of the reappointment process, he was asked to do an annual evaluation of each Magistrate, so they also got his annual evaluation of Judge Terrazas from the preceding year. He was only aware of those documents and Council would need to ask the City Magistrate Merit Selection Commission if they received more documentation.

Michael Rankin, City Attorney, stated it was exactly those documents that would have been provided to Council during Executive Session which under the Arizona State Supreme Court decision in the Doning versus the City of Tucson case had been deemed to be confidential and privileged. Council Member Scott asked if the Citizens' Committee saw them where they bound for life to keep them secret.

Mr. Rankin answered yes, they returned the items to the Clerk after the completion of their executive session prior to making their recommendation.

Mayor Pro-Tempore Dunbar recognized Judge Terrazas.

Judge Terrazas read into the record a written statement regarding why she should be reappointed.

Mayor Pro-Tempore Dunbar called on Commissioner Dick Dunbar, Vice Chair of the City Magistrate Merit Selection Commission.

Commissioner Dunbar, representing the Magistrate Merit Selection Commission, gave an overview of the make up of the Commission. Regarding the meeting that was held he said the Commission operated in executive session and he stated he was not allowed to discuss particulars of the individual discussions.

At the request of Council Member Scott, Commission Dunbar stated he was married to Vice Mayor Dunbar and that he was a resident of the City of Tucson.

At the request of Council Member Scott, Mr. Rankin advised that the marital relationship between the Vice Mayor and Commissioner Dunbar does not present a conflict of interest under the relevant Arizona Statutes.

Mayor Pro-Tempore Dunbar stated for the record that she sat on the Magistrate Merit Selection Commission for five years before being elected to the Arizona Legislature. She asked if there were any other questions for Commissioner Dunbar.

Council Member Ronstadt asked Commissioner Dunbar if he had been given evaluations from previous violations, there had to be at least one in the past.

Commissioner Dunbar stated at the end of every meeting materials given to the Commission by the court were collected and destroyed. There were no materials available from four years ago, or two years ago, or even from the past meeting.

Council Member Ronstadt stated there was an indication two members of the Commission had been through the process before.

Commissioner Dunbar stated it was Sally Reynolds and himself.

Council Member Ronstadt asked if they were able to give a historical perspective based on the last evaluation.

Commissioner Dunbar stated he was silent during the entire piece.

Mayor Pro-Tempore Dunbar asked Commissioner Dunbar what was the vote of the Commission.

Commissioner Dunbar stated the vote was unanimous to not reappoint as summarized in the letter to Mayor and Council.

Mayor Pro-Tempore Dunbar asked how many years Judge Terrazas had been on the bench.

Commissioner Dunbar stated it had been twelve years.

Council Member Ibarra asked what the vote was of the Commission at the last reappointment.

Commissioner Dunbar stated he had made the motion to reappoint Judge Terrazas, but that he did not recall the vote.

Council Member Ibarra thought it was a unanimous vote also and the Commission had gushing comments, as he recalled. During the last two reappointments, the Commission only had positive response and gleaming remarks regarding Judge Terrazas.

Council Member Ibarra asked what the issues were that led to the recommendation not to reappoint.

Mr. Rankin stated Commissioner Dunbar could not discuss any of the specific discussions that occurred in Executive Sessions. He could identify categories or elements that were of concern to the Commission.

Council Member Ibarra said the Council could have gone into Executive Session to find out the information. He stated it would be more appropriate to do it in public and people would not think a deal was made in the back room. Council Member Ibarra asked Commissioner Dunbar to be general in the aspects of it all.

Commissioner Dunbar said the issues were dealing with service not the statistical data they received. The issues had to deal more with an employee of the City of Tucson, the demeanor as a person working in City Court, demeanor with working with coworkers, and the treatment of people that come in contact with the court system. It did not have to do with specifics related to judicial knowledge, judicial fairness or practice of law. It had more to do with how they are as an employee and how they handle questions relating to issues brought to the Commission's attention by some of the people who testified in Executive Session.

Council Member Ibarra said as a judicial aspect, as a profession in the knowledge of the law, they want a judge who had a strong knowledge of the law, and a strong background. Commissioner Dunbar stated that was the reason why there were four attorneys appointed by the Bar to the Commission.

Mr. Rankin stated he needed to cut it off before it went into specific discussions of the Executive Sessions. He stated Commissioner Dunbar was in an awkward position because he was being asked to engage into an open discussion about something he was under legal obligation not to divulge.

Council Member Ibarra asked of the respondents who gave back information if they were an average resident who had gone in front of Judge Terrazas. Was that one of the things the Commission looked at.

Commissioner Dunbar stated there were four categories of surveys. There were the staff, witnesses, jurors, and litigants. It was the number of responses from staff that was considerably larger than usual.

Council Member Ronstadt asked if during Executive Session were they were provided with Judge Riojos' evaluation.

Commissioner Dunbar answered yes.

Council Member Ronstadt then asked if it had an effect on the germination on the Commission's determination.

Mr. Rankin rephrased the question and asked if it was something that was considered prior to the recommendation being made.

Commissioner Dunbar answered yes.

Mayor Pro-Tempore Dunbar stated Judge Terrazas was asked to pick out two speakers to speak on her behalf. She had selected James Nesci as one of them.

James Nesci, Criminal Defense Attorney, spoke in support of Judge Terrazas.

Mayor Pro-Tempore Dunbar called on Lori Oien.

Lori Oien, Commissioner on the Magistrate Merit Selection Commission, said the decision not to reappoint was not taken lightly. She had wished the Mayor and Council would have gone into Executive Session and saw what the Commission had seen to help them make their decision, the Council was only seeing part of it.

Mayor Pro-Tempore Dunbar called on John Piazza.

John Piazza, City Prosecutor, said his current assignment was in Judge Terrazas' courtroom and he was there on his own behalf and not representing the City Prosecutor's office. Mr. Piazza spoke in support of Judge Terrazas.

Council Member Scott asked what the City of Tucson's policy was when they receive anonymous comments on the comment line or otherwise.

Michael Letcher, Deputy City Manager, stated it depended on the item received. In the past there had been items personally directed that were not substantiated. Those items were not followed up on if it was a personal attack. If it was anonymous it would be hard to get in contact with the individual.

Council Member Scott stated the newspapers do not publish anonymous letters to the editors. They feel if one had a comment to make one should stand by it and print their name.

Mayor Pro-Tempore Dunbar asked for a point of clarification. People were allowed to come forward, but their names were not included in order to protect them.

Mr. Rankin stated the Judicial Performance Reviews and the narrative comments, which would have been looked at by the Magistrate Merit Selection Commission were anonymous. He said the surveys were provided to the attorneys who practice in front of the judge. The goal of the process was to get as many of the surveys returned as possible so there could be some type of representative sample. The policy was the surveys remain anonymous to encourage participation rather than having people who were going to practice in front of the judge signing their name to an evaluation of that judge, for obvious reasons.

Council Member West stated when she was a college teacher, students would evaluate her each term and the performance evaluations were anonymous, so she understood the process. She did not think those kinds of rating surveys were unusual.

She said four years ago she voted in favor of retaining Judge Terrazas. Sometime afterwards, the Arizona Daily Star had published an article stating the recently reappointed judge had a rating of below fifty percent. She had constituents who called her and asked her how she could have voted in favor of the reappointment. At the time, the Council received no information and they were only given the information from the Magistrate Merit Selection Commission. This time she received a folder full of material, which she read. There were letters that the judge had seen and there were also some damaging phrases that she had rebutted. Council Member West stated she had not shared it with anyone nor would she. For that reason, she was hoping the Council would have gone into Executive Session, as those were personnel records. It would have been a good idea if Council had gone into Executive Session, because the surveys did not tell them Some of the information she had received in the folder gave her cause for much. concern. When the meeting was over, she would be giving the folder back to the City Clerk so it would not be distributed to anyone. Because of the experience, she thought when the Council appoints a Magistrate Merit Selection Commission to review those materials in Executive Session, they needed to look seriously at their recommendation.

Council Member West thought Judge Terrazas was a bright and hard working person. Where things fell apart were on the judicial temperament side of things and that was important in a judge.

Council Member Ibarra stated he remembered the article also. He wondered if they were not able to talk about details, the chairman was not able to be specific, and no one else could be specific because of executive session materials attached, why the article contained a lot of information that was released to the press that was executive session material. No one ever found out why or how the information was released. Council Member Ibarra stated that now one of his colleagues was using that information as the main issue to vote against the reappointment. It seems like it was not being treated in a fair and equable manner.

Council Member West said because she was concerned about the information that was released previously, she read very carefully all the information in the folder and based on it she could make a decision that was not based on newspaper articles four years ago.

Council Member Leal said this was difficult because of the two parts of the system, the statistical part and the anonymous comments. As history had shown anonymity had been a curtain for injustice to hide behind, but at the same time anonymity provides some security on the part of individuals who may comment without fear of reprisals.

Council Member Leal found it ironic that they were talking about a judge. He wondered what was the most important part of the job. Trying to discover justice, trying to render justice, and what was looked at when trying to reappoint them. Again, it called further into question the process. When information got into the press and they started using statistics, which were already skewed and constituents were calling the Council offices concerned about the statistics, it was like every step of the process got more unreal. Less dealing with reality and less dealing with what had happened to the person's life in the courtroom over time.

Council Member Leal thought it was meaningful to hear that two attorneys from opposing sides agree on the integrity and the working relationships Judge Terrazas had with the community that came before her bench. The Magistrate Merit Selection Commission had to make a decision based on information and processes that missed the point. Council Member Leal was there when she was reappointed last time and saw the recommendations she received.

It was moved by Council Member Leal, duly seconded, to pass and adopt Ordinance <u>10138</u> reappointing Judge Terrazas.

Council Member Ronstadt said the Presiding Magistrate's recommendation and job appraisal were not anonymous. So there was testimony with people who put their name on it. He stated he was disappointed that he was not able to review the materials.

He thought it was unfortunate for Judge Terrazas because it may have changed his position to see what the Magistrate Merit Selection Commission saw and he may have had a different perspective, but he was not given that opportunity. He said that the Good Government Subcommittee tried to change the process to make it more objective, but was shot down for a whole host of reasons. Council Member Ronstadt said the major issues he had were the conflict of interest that exists by having lawyers, police officers, and city staff, whom the judge can directly affect, come and testify. He wished he had been given the opportunity to review the materials. All he could rely on was the seven to zero vote from the Commission.

Council Member Scott stated concerns of one member of the Council having a packet of information that no one else had seen.

Mayor Pro-Tempore Dunbar stated everyone had been delivered the packet of information.

Council Member Scott asked if the packet was public documents.

Mr. Rankin stated he needed to look at the packet and see what was included. The things that would be treated as confidential would be the same things that were set aside for the Council's possible consideration in executive session which would have been the narrative comments in the individual evaluations. The statistical summaries that were provided or any information in the packet that was provided by Magistrate Terrazas to support her position would be subject to release, as long as they did not include those other things.

Council Member West stated she had received the packet from the Judge. There was additional letters in the packet and some of it was sensitive.

Council Member Scott said she had some concerns of what the results of the Magistrate Merit Selection Commission's recommendations had been of late. A casual observer might note, and this might be coincidental, that they had not recommended anyone lately who was a minority.

Council Member Ronstadt said he found the comment offensive. The Council Member was alleging there was a conspiracy among the Magistrate Merit Selection Commissioners. She would need to provide evidence and to him that was slander.

Council Member Scott said that it might appear to the public as being so. She had not made any accusations and she would make it very clear if she had.

Council Member West asked the vice chair of the Magistrate Merit Selection Commission to speak if it was true.

Commissioner Dunbar stated Presiding Magistrate Riojas came before them with a unanimous recommendation.

Mayor Pro-Tempore Dunbar said she could only think of one that came with a divided vote on a recommendation. This was the first she could remember in twelve years that there was a vote for non-reappointment. She was on the Commission four

years ago, the first time Judge Terrazas came forward and it was very divisive. She said the meeting had to be held over several nights and it was extremely contentious and was not a unanimous vote at that time.

Mayor Pro-Tempore Dunbar asked if there were any further comment, hearing none she asked the City Clerk to read Ordinance <u>10138</u> by number and title only.

Ordinance <u>10138</u> relating to City Magistrates; appointing Gilda Terrazas as City Magistrate of the City of Tucson; fixing compensation and declaring an emergency.

Upon roll call, the results were:

Mayor Pro-Tempore Dunbar asked Mr. Rankin to explain what would happen next.

Mr. Rankin stated there was no reappointment of Judge Terrazas. Her term would expire on April 6, 2005. She would go into holdover status and would continue to serve as a magistrate until the Magistrate Merit Selection Commission was directed by the Mayor and Council to begin a process for the selection of a new magistrate.

Council Member Ronstadt asked if that could be considered as a future agenda item.

Mr. Rankin said the Council could use the Agenda Committee Meeting as an opportunity to schedule that item.

# 4. CITY MANAGER'S REPORT: SUMMARY OF CURRENT EVENTS

Kathleen S. Detrick, City Clerk, stated the first item to be considered separately was item 5b3, Casa Vicente. A protest had been filed and the owner was present. The license is located in Ward 6.

Council Member Ronstadt asked Vicente Sanchez-Martinez, the applicant, to address the Council and state what he had done in regards to the one protest letter.

Mr. Sanchez-Martinez stated he had contacted the protestor who had concerns about any alcohol downtown. He explained to her what type of restaurant he opened, which featured food from Spain and wanted to offer drinks to go with dinner. He said that the business also had a cultural center and was currently opened for lunch so you could eat in Spain without flying. He said that he was a family man, he had two children thirteen and fourteen years old. He was committed to downtown. He had an architecture business downtown also, not far from the restaurant. He had put a lot of his life adventures into this restaurant and hoped that the Mayor and Council would support him in this adventure in culinary arts.

Council Member Ronstadt stated Casa Vicente was a Series 12 liquor license that did not establish location and they were encouraging restaurants in the downtown area.

It was moved by Council Member Ronstadt, duly seconded, and carried by a voice vote of 6 to 0 (Mayor Walkup absent/excused) to forward liquor license application 5b3 to the Arizona State Liquor Board with a recommendation for approval.
