#### 2. INVOCATION AND PLEDGE OF ALLEGIANCE

The invocation was given by Yolanda Lozano, City Clerk's Office, after which the Pledge of Allegiance was presented by the entire assembly.

#### 3. MAYOR AND COUNCIL REPORT: SUMMARY OF CURRENT EVENTS

Mayor Walkup announced City Manager's communication number 126, dated April 6, 2010, was received into and made part of the record. He also announced this was the time scheduled to allow members of the Mayor and Council to report on current events and asked if there were any reports.

- a. Vice Mayor Glassman announced the Ward 2 Council Office was distributing over ten thousand copies of the children's book entitled, "Jeremy Jackrabbit Harvests the Rain" on rainwater harvesting to local elementary schools. He congratulated his wife, Sasha, who was a partner on the project and thanked the community sponsors that made the distribution of the book possible.
- b. Council Member Romero announced and invited everyone to participate in the first ever "Cyclovia Tucson" on April 18, 2010. She said the word, "Cyclovia," meant "temporary closure of a network of streets to cars, and opening the streets to those who biked, walked, and skated."
- c. Council Member Uhlich announced she was excited and that a good portion of the "Cyclovia" route went through Ward 3 and reiterated Council Member Romero's announcement. She also reported that the Jefferson Park Neighborhood's garden tour, a fundraiser to help with their preservation efforts, was on April 18, 2010.

Roger W. Randolph, City Clerk, announced the item to be considered separately was Item 5b1, Mercado y Carneceria Mexicana, located in Ward 5.

Council Member Fimbres asked to hear from one person in support of and one person in opposition to the license. He stated the applicant was present and asked if they wanted to make any comments.

Thomas Aguilera, Aguilera Law Group, representing the Applicant said there were some folks present that were in support of the license. He said they had been in contact with Melinda Jacobs, Ward 5 Council Administrative Assistant and she confirmed that all of the one hundred five signatures and nine letters received in support of the application were within the one-mile radius.

Mr. Aguilera said one thing that was brought to his attention, by Council Member Fimbres, was the fact that there a few licenses in that area and there could be a saturation issue. Mr. Aguilera said the way the corridors of Sixth Avenue and Twelfth Avenue ran, it seemed to him that driving around Sixth Avenue was different, versus driving on Twelfth Avenue. He said the licenses on Sixth Avenue were more like liquor stores and the license in question was for a market, which would sell beer and wine; it was not a liquor store.

Mr. Aguilera said the Applicant, Jose Luis Cornejo, was present, as were supporters from the neighborhoods. He asked them to stand up so that they could be acknowledged.

Council Member Fimbres asked the individual opposing the license to come forward.

Annabelle Nuñez said she was a member and a resident in the Ward 5 area and the business was located in the National City Neighborhood Association (NCNA). She said she was before Mayor and Council many times before regarding liquor licenses in her area. She said the NCNA met with the applicant on March 24, 2010, to discuss some of the issues and concerns they had, and it was not just the NCNA, but also the Southside Neighborhood Association Presidential Partnership (SNAPP). She asked those in attendance who agreed with the protest to stand, which also included members from the Cherrybell Neighborhood, as well as, Luz Social Services Agency.

Ms. Nuñez expressed some of the concerns she and the neighbors in the area had. She commented that the Mayor and Council obviously received their letters of protest and that she also included a bibliography of studies that related to access of alcohol sales in the neighborhood. She said it was documented that crime increased when there was easy access to alcohol, and indicated there were at least sixteen outlets, if not more, that had access to liquor by way of restaurants, liquor stores, drive-thru's, and markets fronting as liquor vendors. She said she recently saw that there was a church across the street, and was not clear if the church was there before or after the application was filed. She said it was difficult to tell when the actual protest period was over, because the applicant did not place the sign in a visible place. It was placed on the door, but during business hours, the door remained open; so it was difficult for the neighbors to see that

there was an application in process. Therefore, a lot of the neighbors were unaware of the liquor application.

Ms. Nuñez reiterated that the location had a denial in the past from the Arizona State Liquor Board, due to saturation issues. She spoke about crime in the area that took place in 2007, where a person was on the phone outside of the business, was shot and murdered in broad daylight. She said in 2008, two blocks down the street from the business; another shooting took place where four individuals were shot and one died. Four blocks down the street at another business, she said there was another shooting where another individual was murdered. She said all of that was only within a four or five-block area, along the South Sixth Avenue corridor.

Ms. Nuñez said that when they met with the applicant, they brought up the fact about beer skips, and the applicant did not quite understand what that was. The applicant indicated to them that he would lock the doors. She said the applicant did not understand that the doors could not be locked during business hours, and if he did not understand the legalities of having a license, that was a concern to them. The applicant did not quite understand or indicate to them that he understood what the quality of life issues were. She said she and many others had resided in the area for twenty, thirty and forty years, and were concerned about the applicant not being able to articulate how having the license would best serve the community. She said they understood that it was an economic need, but he indicated it was because of competition.

Ms. Nuñez said they spoke about placing signs on the business, but the only signs that were seen had been for phone cards and others unrelated to groceries. There were never any signs, marketing groceries, as they indicated they were a grocery store, that they had certain products on sale. She said in the past, when they met with other applicants, they indicated they would comply with many of their issues and concerns, but once the license was granted, that did not happen. She said all of a sudden the beer signs appeared and the establishments were either restaurants or grocery stores, but it was always about the beer and what beer was on sale. Ms. Nuñez asked the Mayor and Council to reconsider and recommend a denial to the Arizona State Liquor Board.

Council Member Fimbres thanked Ms. Nuñez and said that based on the information given to them beforehand, he recommended that the application be forwarded to the Arizona State Liquor Board with a "no recommendation" since there were one hundred twenty-five signatures and eight letters of support, but, he said, there were also protests of the license and the neighborhood leadership did not support the license.

It was moved by Council Member Fimbres, duly seconded and carried by a voice vote of 7 to 0, to forward liquor license application 5b1 to the Arizona State Liquor Board with a no recommendation.

#### 6. CALL TO THE AUDIENCE

Mayor Walkup announced this was the time any member of the public was allowed to address the Mayor and Council on any issue except for items scheduled for a public hearing. Speakers were limited to three-minute presentations.

- c. Donald Pitt urged the Mayor and Council to gather all the right positive and negative facts that the F-35's would have in Tucson, and to distribute that information to the community.
- d. Anne Gomez expressed her concerns if the F-35's made Tucson their home and the negative impacts it would have on the community.
- e. Jean DeJong spoke in opposition to the F-35's flying over the City.
- f. Gary Hunter spoke about the economic impacts the City faced if the F-35's came to Tucson.
- g. Lyle Cartwright spoke in opposition to the F-35's and the damage it would cause to a person's hearing.
- h. Pete Simon spoke about his plans and ideas for the Rio Nuevo projects and asked the Mayor and Council to review them.
- i. Hugh Fox asked the Mayor and Council to have Davis-Monthan Air Force demonstrate fly-by's of the F-35's for a couple of weeks so that the community would know what the effects of the F-35's would be.

Mike Rankin, City Attorney, stated that the Development Agreement Amendment had been revised to correct some scrivener's errors and substituted a fully executed signature page with no substantive changes.

Mayor Walkup asked if there was any discussion. Hearing none, he asked for a roll call vote.

## 8. PUBLIC HEARING: TUCSON CODE – AMENDING (CHAPTER 23) THE LAND USE CODE; AFFECTING THE LOCATION OF CHARTER SCHOOLS IN SINGLE FAMILY RESIDENCES

Mayor Walkup announced City Manager's communication number 130, dated April 6, 2010, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on the proposed amendment to the Tucson Code, Chapter 23, the *Land Use Code* prohibiting a single family residence on less than one acre from being occupied as or converted into a State regulated Charter School. He said before beginning the public hearing staff wanted make a brief statement.

Ernie Duarte, Planning and Development Services Department Director, said this was a follow up item that was brought before the Mayor and Council in November 2009. He said in October 2009, the Arizona Revised Statutes were amended to exempt Charter Schools from zoning regulations, same as public schools. He said the bill did not require amendments to the City's *Land Use Code (LUC)*. However, there was one optional provision that stated a county or municipality may adopt zoning regulations that would prohibit a Charter School from operating in an existing single family residence that was located on property of less than one acre. He said the proposal amended the *LUC* to enact that provision. He said the item had been reviewed by the *LUC* Committee and the City's Planning Commission in a public hearing.

Mayor Walkup announced the public hearing was scheduled to last no more than one hour and speakers were limited to five-minute presentations. He asked if there was anyone wishing to be heard on this item.

Robert Reus said he had rearranged his afternoon and put off his dinner so he could address the Mayor and Council on important information during the Call to the Audience. He said it was an insult to him and everyone else who had already left without being able to speak, and that the Mayor and Council should be ashamed of themselves for that.

An unidentified speaker also commented about not being able to speak during the Call to the Audience. She said Mayor Walkup was calling speakers in the order the cards were received, but stated that was not true as she was present much earlier than that. She said as a stress reduction expert, she had very pertinent information about the affects of noise on the ability of children to learn and on longevity of people who lived near airports.

Mayor Walkup assured the unidentified speaker that he called on the speakers in the order he received them, and said there were cards filled out at ten in the morning.

Mayor Walkup asked if there was anyone else wishing to speak

It was moved by Council Member Scott, duly seconded and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Walkup asked if there was any discussion.

Council Member Kozachik said he had a question regarding page two of the document they received. It read that applicants who wished to locate a charter school in a residence on less than one acre may seek a modification to proposed performance criteria through the special exception LUC. He said that in the Ordinance it read that a single-family residence, on less than one-acre, shall not be occupied as or converted into. He asked if that was a clarification of language that needed to be addressed.

Mr. Duarte said that was an item that came up during the public hearing before the Planning Commission. He said it had been City policy to allow some avenues of relief for applicants that did not meet the performance criteria, and in this case, the avenue of relief was the special exception process. He stated that came into play if there was a proposed charter school that wanted to go into a facility that was on one acre or less and had neighborhood support that wanted them and worked out those issues. He said it provided an avenue for someone to take advantage of the special exception provision.

Council Member Kozachik said he understood, but the language in the Ordinance said it shall not be occupied. He asked if that was a contradiction.

Mike Rankin, City Attorney, replied that Council Member Kozachik was reading the language correctly, but by engaging in the special exception process, they could get relief from that provision and that was how it worked.

Mayor Walkup asked the City Clerk to read Ordinance <u>10772</u> by number and title only.

Ordinance No. <u>10774</u> relating to zoning: amending zoning district boundaries in the area located on the northeast corner of Golf Links and Houghton Roads in Case C9-08-10, COT Water – Golf Links Road, SR to C-2; and setting an effective date.

Roger W. Randolph, City Clerk, announced a three-fourths majority vote was required to approve the rezoning ordinance.

It was moved by Council Member Scott, duly seconded, to approve the request for rezoning as recommended by the Zoning Examiner and pass and adopt Ordinance 10774.

Mayor Walkup asked if there was any discussion. Hearing none, he asked for a roll call vote.
