2. PUBLIC HEARING: CITY OF TUCSON/PIMA COUNTY CONSORTIUM FIVE YEAR FOR HOUSING AND URBAN DEVELOPMENT FISCAL YEARS 2010 TO 2014

Chair Walkup announced City Manager's communication number 124, dated April 6, 2010, was received into and made a part of the record. He also announced this was the time and place legally advertised for a public hearing on the Updated Five Year Plan. The public hearing was scheduled to last for no more than one hour and speakers were limited to five-minute presentations.
