#### 7. CONSENT AGENDA

Mayor Rothschild announced Item o was being considered separately at the request of Council Member Romero.

Council Member Romero stated she wanted to ensure that an addition to the Resolution be read in to the record. She said she thought Ms. Isaacs was clear on the motivation for the Resolution. Personally, she said she believed profits should not be a motivation for any part of the justice system and making a business out of incarcerating people was inhumane. She also stated her belief was that the Mayor and Council were leading the City of Tucson in the appropriate direction to make sure that they were not investing in private prisons and profiteering from other people's incarceration. She invited Vice Mayor Cunningham to speak if he had any comments, along with asking the City Attorney to add Section 2 which clarified the position of the City of Tucson in terms of monitoring.

Vice Mayor Cunningham stated he was pleased to co-sponsor the item. He said there were many different things that should function with the free market along with things being able to function in government; prisons, schools, and roads should all be in government. He said there was no room for them to function as private entities. He said there was not enough oversight, or enough funding or security involved when the government was not doing those things.

Vice Mayor Cunningham said there had been this war on government over the past forty years where people went around saying, the government was this and the government was that. He went on to say the problem was that there were several things the government was supposed do. He stated one of those things was to keep the people safe and by doing that meant to incarcerate those who deserved to be incarcerated. He also mentioned that while these people were incarcerated, the government should ensure their protection and correction.

Vice Mayor Cunningham remarked it was called the Department of Corrections (DOC) not the Department of Punishment. He said that was what the DOC was supposed to do. He made the comment that everyone, at some point, had someone they knew, a friend or relative, who at one time was incarcerated. He went on to state that lots of different people deserve second chances and that was what this Resolution was supposed to do. He said with his background working in probation, he understood law enforcement and keeping everyone safe, however, at the same time, it should be a function of government not profiteering.

Mayor Rothschild directed the City Attorney to read into the record the proposed amendment.

Michael Rankin, City Attorney, stated as discussed during the Study Session earlier that afternoon, the proposed addition to the Resolution would add a new Section 2 that read, "The provisions of Section 1 above shall not prevent or limit the City's ability to participate in contracts that relate to programs that provide alternatives to detention, such as home detention or monitored probation programs. Prior to the expansion of any such programs, the consideration of any contracts for that purpose will be brought to the Mayor and Council for consideration and direction."

Council Member Durham asked that the language be re-read.

Mr. Rankin re-stated the language, "The provisions of Section 1 above shall not prevent or limit the City's ability to participate in contracts that relate to programs that provide alternatives to detention, such as home detention or monitored probation programs. Prior to the expansion of any such programs, the consideration of any contracts for that purpose will be brought to the Mayor and Council for consideration and direction."

Council Member Fimbres asked if the County also had a set Resolution.

Mr. Rankin stated the County had previously adopted a Resolution in opposition of the private operation of detention facilities. He said their language was a little different and also referenced contracts for court programs, rehabilitation and other elements. He said there was some concern that the real intent was not clear and that was the reasoning for rephrasing the Resolution.

Council Member Kozachik asked if the City currently contracted with any privately funded diversion programs that pulled people out of and incarcerated them under the terms of the Resolution.

Mr. Rankin stated that the City contracted with firms for home detention programs, certain monitored probation services, and various vendors that participated in the diversion programs. He said under the new language of this Resolution, it would not apply to the City's rehabilitation programs, which were the City's diversion programs and providers for the City's "Specialty Courts," in particular mental health services, veteran's court, etc. Additionally, he stated Section 2 with the additional language would not require any changes be made to the existing contracts for the home detention or the monitored probation programs.

Council Member Kozachik asked what an expansion was.

Mr. Rankin explained an expansion was if the City wanted to engage in a new type of program that required a new contract, and provided for programs the City was not currently providing, the Mayor and Council, in advance, had to engage in those types of services.

Council Member Kozachik stated that none of the Council Members supported a private prison industry. He said that he did not want to force the Council into any type of positon that if there was an option for someone to engage in a privately funded diversion program that allowed them to leave prison and re-engage, he did not want to take that option off the table. He asked if there was anything in the Resolution that did that.

Mr. Rankin replied "no", and indicated that Section 2 of the Resolution clarified that along with the making of the record of this meeting gave staff additional direction to know what was exactly meant by the Resolution.

Vice Mayor Cunningham stated it basically gave the City the "backdoor" just in case someone was on home dentition, like electronic monitoring or any kind of probation but was monitored by a private contractor, that they could be released. He said that was what the Resolution was for.

Council Member Kozachik reiterated this was not for people to be "reimprisoned".

Council Member Romero stated that electronic monitoring was also profiteering. She said the information that was passed along described how the private incarceration industry was making money off of monitoring systems and other programs that were for profit programs disguised as home incarceration program. She said she agreed there needed be a section of provision that did not disallow the City of Tucson to continue using monitoring systems and at-home incarceration methods.

Council Member Romero said the City needed to be very careful of where they were investing their money. She stated some of those monitoring systems were charging high rates to individuals that were using their systems. She stated the City, and any future Mayor and Council, should be part of this conversation if it were to expand. She also stated that the City was moving in the right direction and they did not want to invest in profiteering out of incarceration. She commented that there was the possibility of continuing to use the monitoring system because as explained to her by the City Attorney, most of the monitoring companies used by government were private.

Council Member Romero commented that people being monitored at home should not be re-incarcerated, but at the same time, the City needed to be careful as to where they investing.

It was moved by Council Member Romero, duly seconded to pass and adopt Resolution 22888, as amended.

Council Member Durham stated this was the reason why the Mayor and Council were reviewing all new contracts to ensure they were appropriate.

Council Member Romero agreed that was the reason for the new language.

The motion to pass and adopt Resolution <u>22888</u>, as amended, was passed and adopted by a roll call vote of 7 to 0.

# 8. PUBLIC HEARING: ZONING (C9-12-08) HERMAN VENTURES – GLENN STREET, MH-1 TO I-1, CHANGE OF CONDITIONS AND PRELIMINARY DEVELOPMENT PLAN, ORDINANCE ADOPTION

Mayor Rothschild announced City Manager's communication number 146, dated May 8, 2018, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on a request for a Change of

Conditions and Preliminary Development Plan for property located on the north side of Glenn Street west of Fairview Avenue.

Mayor Rothschild asked if the applicant or representative was present and agreeable to the proposed requirements.

Shawn Wojtcuk, SKW Contractors LLC, America Roofing, stated they were agreeable to the proposed requirements.

Mayor Rothschild announced the public hearing was scheduled to last for no more than one hour and speakers were limited to five-minute presentations. He asked if there was anyone wishing to be heard on the item.

There was no one.

It was moved by Council Member Fimbres, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Rothschild asked the City Clerk to read Ordinance <u>11547</u> by number and title only.

Ordinance No. <u>11547</u> relating to Zoning: amending certain rezoning conditions for property located on the north side of Glenn Street, approximately 110 feet west of Fairview Avenue in case C9-12-08 Herman Ventures - Glenn Street, MH-1 to I-1 zone; and setting an effective date.

It was moved by Council Member Durham, duly seconded, and passed by a roll call vote 7 to 0, to approve the request as presented and pass and adopt Ordinance 11547.

## 9. PUBLIC HEARING: CITY OF TUCSON RECOMMENDED ANNUAL BUDGET FOR FISCAL YEAR 2019

Mayor Rothschild announced City Manager's Communication number 150, dated May 8, 2018, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on the Fiscal Year 2019 recommended budget.

Mayor Rothschild announced the public hearing was scheduled to last-no more than one hour and speakers are limited to five minute presentations. He asked if there was anyone wishing to be heard on the item.

There was no one.

It was moved by Council Member Fimbres, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Rothschild announced the tentative adoption of the Fiscal Year 2019 Budget was scheduled for May 22, 2018. He said another legally required public hearing was scheduled for June 5, 2018, for the purpose of public comment on the budget as tentatively adopted at the May 22, 2017 Mayor and Council Meeting.

## 10. ZONING: (C9-16-01) YERGER – 39TH STREET, I-1 TO O-3, ORDINANCE ADOPTION

Mayor Rothschild announced City Manager's Communication number 147, dated May 8, 2018, is received into and made part of the record. He asked the City Clerk to read Ordinance <u>11548</u> by number and title only.

Ordinance No. <u>11548</u> relating to zoning: amending zoning district boundaries in the area located approximately 100 feet south of 39<sup>th</sup> Street and approximately 155 feet west of Park Avenue in case C9-16-01, Yerger- 39<sup>th</sup> Street, I-1 to O-3; and setting an effective date.
