The Mayor and Council of the City of Tucson met in regular session in the Mayor and Council Chambers in City Hall, 255 West Alameda Street, Tucson, Arizona, at 5:35 p.m., on Tuesday, June 5, 2012, all members having been notified of the time and place thereof.

Council Member Uhlich requested that Roberto Villaseñor, Tucson Police Department Chief of Police, follow up with Chad Benham regarding an opt-out provision of Ordinance 10967 for third-party alarm provisions.

- f. TRANSPORTATION: AUTHORIZATION TO SUBMIT FEDERAL TRANSPORTATION ENHANCEMENT PROJECT PROPOSALS
 - 1. Report from City Manager JUN05-12-224 CITY WIDE
 - 2. Resolution No. <u>21908</u> Relating to Transportation; authorizing the Director of the City of Tucson Department of Transportation to submit and sponsor five (5) Federal Surface Transportation Program (STP) Round 19 Transportation Enhancement Project Proposals to the Arizona Department of Transportation Review Committee; and declaring an emergency.

Council Member Uhlich asked Andrew Quigley, Interim Assistant City Manager, to give an outline of the process used by the Transportation Department in the selection of projects submitted for grants.

Mr. Quigley explained that the Transportation Enhancement Projects were developed by both Transportation staff and the general public. The department's policy was to support any suggested project, as long as the funding source for the local match was identified. He said the source was often the Regional Transportation Authority (RTA), but in certain cases, projects received private funding. He added that the Arizona Department of Transportation had established the maximum funding level at seven hundred and fifty thousand dollars.

Mr. Quigley further explained the applications were often generated at the grass-roots level, which ensured neighborhood awareness and support of suggested projects, and if a project received approval at the State level, there would be significant public outreach during the planning and design phases. He noted the Transportation Department did not prioritize the projects. He also clarified that the Neon Sign District was along the Miracle Mile corridor, roughly from Stone Avenue to Drachman Street.

Council Member Uhlich asked about street and road investments located on the University of Arizona campus, specifically at Highland Avenue and Olive Street.

Mr. Quigley replied that the investments were to address safety and congestion concerns regarding the intersection which the University of Arizona and the biking public brought to their attention.

It was moved by Council Member Uhlich, duly seconded, that Consent Agenda Item f be passed and adopted and the proper action taken.

Council Member Romero acknowledged Diana Rhoades and Laura Dent from the Ward 1 Council Office for their work on the application for the Transportation Enhancement Grant for South Twelfth Avenue pedestrian, safety and beautification improvements.

Consent Agenda Item f was declared passed and adopted by a roll call vote of 7-0.

8. PUBLIC HEARING: 2013 BUDGET AS TENTATIVELY ADOPTED ON MAY 15, 2012

Mayor Rothschild annouced City Manager's communication number 226, dated June 5, 2012, was received into and part part of the record. He also announced this was the time and place legally advertised for a public hearing on the Budget. He said the public hearing was scheduled to last for no more than one hour and speakers were limited to five minute presentations.

Mikki Niemi expressed his concerns, and Dale Schmedding spoke on behalf of the Tucson Bus Rider's Union regarding the Transportation budget.

It was moved by Council Member Fimbres, duly seconded, and carried by a voice vote of 7 to 0 to close the public hearing.

Mayor Rothschild announced the Council would stand adjourned and convene a special meeting for the adoption of the budget.

9. ECONOMIC DEVELOPMENT: ADOPTION OF AN APPLICATION AND REVIEW PROCESS FOR ECONOMIC DEVELOPMENT INCENTIVES

Mayor Rothschild announced City Manager's communication number 232, dated June 5, 2012, was received into and made part of the record. He asked the City Clerk to read Resolution <u>21913</u> by number and title only.

Resolution No. <u>21913</u> relating to Economic Development; approving a Primary Jobs Incentive Program; and declaring an emergency.

Dave Deibel, Deputy City Attorney, read the following corrections into the record: The title of Resolution <u>21913</u> should read "Relating to Economic Development; approving adoption of an Application and Review Process for Economic Development Incentives; and declaring an emergency."

On page 3, Step 1, the following sentence was added to the end of the first paragraph: "During this step, the applicant must also brief the Council Member who represents the area in which the project is located."

On page 5, the section entitled Primary Job Incentive Program, first bullet should read "Employer invests at least five million dollars in new or expanded facilities within the city limits." Second bullet should read "Employer creates a minimum of twenty-five new primary non-retail jobs that pay average wages of at least one-hundred and fifty percent of mean annual earnings of the Tucson MSA, and at least fifty-one percent of all local employees earn at least this wage."

Council Member Romero requested assurance that living wages and local jobs were part of the direction.

Mr. Deibel replied affirmatively. He also stated that as the program is utilized and projects come forward, Mayor and Council would probably want to look at making changes to the process.

Council Member Uhlich requested affirmation that the Section 108 program was not limited to downtown.

Albert Elias, Housing and Community Development Director, replied that was correct, the Section 108 program would be available anywhere in the city limits.

Additional comments were made by Mayor Rothschild, Vice Mayor Kozachik and Council Member Uhlich regarding the overall RFP process and that it should begin with Debby Chandler, Economic Development Manager.

It was moved by Council Member Uhlich, duly seconded, and passed by a roll vote of 7 to 0, to pass and adopt Resolution <u>21913</u>.

10. APPOINTMENTS TO BOARDS, COMMITTEES AND COMMISSIONS

Mayor Rothschild announced City Manager's communication number 230, dated June 5, 2012, was received into and made part of the record. He asked for a motion to approve the appointments in the report.

It was moved by Council Member Romero, duly seconded, and carried by a voice vote of 7 to 0, to approve the reappointment of Lisa Silveiro to the Metropolitan Education Commission.

Mayor Rothschild asked if there were any personal appointments to be made.

Council Member Cunningham announced his personal appointment of Suzy Gershman to the Tucson-Pima County Historical Commission.

Council Member Fimbres announced his personal appointments of Doug Martin to the Tucson Parks and Recreation Commission, and Malcom R. Pavey to the Tucson-Pima County Metropolitan Energy Commission.
