The Mayor and Council of the City of Tucson met in regular session in the Mayor and Council Chambers in City Hall, 255 West Alameda Street, Tucson, Arizona, at 5:45 p.m., on Tuesday, June 15, 2010, all members having been notified of the time and place thereof.

2. INVOCATION AND PLEDGE OF ALLEGIANCE

The invocation was given by Reverend Glenn Alden, Sunrise Chapel Swedenborgian, after which the Pledge of Allegiance was presented by the entire assembly.

- c. Vice Mayor Scott announced that the Ward 4 office had a summer intern from Sabino High School. She also announced that she and Council Member Romero attended the "Beat the Peak 2010" kick-off event and asked staff from the Tucson Water Department to explain the program.
- d. Council Member Fimbres passed on a safety message regarding pool drownings and the importance of learning CPR. He announced that the El Pueblo Senior Center hosted a Father's Day Celebration.

Roger W. Randolph, City Clerk, announced the item to be considered separately was Item 5b2, Mr. Head's, located in Ward 6.

Council Member Kozachik stated he had received a lot of input regarding this application. He asked the applicant to come forward and make a presentation.

Micah Blatt, Applicant, addressed the Mayor and Council regarding his application stating his business was more than just a bar; it was an art gallery as well, that would support local artists. He gave a description of what his business entailed and how it supported other businesses in the area. He said he met with area neighborhood

associations, received over four hundred local signatures, twenty-two signatures and seven letters from local business owners, and many people in the audience were in support of his application. He asked for the Mayor and Council's support.

Ford Burkhart, West University Neighborhood Association (WUNA), stated he was in opposition of Mr. Head's liquor license application. He said he had lived in the WUNA neighborhood for sixty years and grew up along 4th Avenue when there were only one or two bars between Speedway and 4th Avenue.

Brian McCarthy, West University Neighborhood Association (WUNA) Board Member, spoke in opposition of the liquor license application. He stated he has lived in the neighborhood for about thirty years. He said it use to be a friendly place where you could a get meal and do some interesting shopping. He stated those days were gone as there were a wall-to-wall establishments serving alcohol.

Chris Gans, West University Neighborhood Association (WUNA) President, stated he has lived in the area for about thirty years and WUNA voted not to support Mr. Head's liquor license application. He said they felt they had enough Series 6 bars and establishments that served alcohol within two blocks on 4th Avenue. WUNA was concerned about parking, noise levels and violence in the area. He requested that the Mayor and Council not support the application.

Bruce Hungate, Fourth Avenue Merchant's Association (FAMA), stated he has operated his business, a Dairy Queen, since 1968. He said he was present to reaffirm his opposition for any more Series 6 liquor licenses in the 4th Avenue business district. Mr. Hungate stated parking was a major issue, as well as, the noise that would be created by the open air patio. He stated he was also concerned about the affects on his own business; he would not be able to hear his drive-through customers. Mr. Hungate said that the FAMA voted unanimously not to have any more Series 6 liquor licenses in the area.

Council Member Kozachik stated when Mr. Blatt and his father came to speak with him; he was intrigued by their proposal of Mr. Head's not being just a bar, but an art gallery as well. He said, since then, he heard the concerns from the neighbors, WUNA and FAMA.

It was moved by Council Member Kozachik, duly seconded, and passed by a voice vote of 7 to 0, to forward liquor license application 5b2 to the Arizona State Liquor Board with a recommendation of denial.

6. CALL TO THE AUDIENCE

Mayor Walkup announced this was the time any member of the public was allowed to address the Mayor and Council on any issue except for items scheduled for a public hearing. Speakers were limited to three-minute presentations.

8. PUBLIC HEARING: 2011 BUDGET AS TENTATIVELY ADOPTED ON JUNE 8, 2010

Mayor Walkup announced City Manager's communication number 301, dated June 15, 2010, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on the Budget as tentatively adopted on June 8, 2010. He said the public hearing was scheduled to last for no more than one hour and speakers were limited to five minute presentations.

Jason Aragon, Pan Left Productions, spoke in support of the Tucson-Pima Arts Council (TPAC) and how they took a chance on him when he first began doing his own videos and independent films. He said art was a vital important part of Tucson. He asked that the Mayor and Council continue funding TPAC.

Daniela Ontiveros, Pan Left Productions, spoke in support of the Tucson-Pima Arts Council (TPAC) and her experience working with them. She said she was a producer and video arts teacher that began her career by writing and receiving a grant through TPAC. As a teacher, she had to teach youth how to be critical thinkers and how to create and express themselves. She asked for the Mayor and Council's continued support.

Elizabeth Burden, member of the Tucson-Pima Arts Council (TPAC) Arts Advocacy Network, spoke in support of funding for TPAC. She thanked the Mayor and Council for including TPAC in their budget. She said the people in support of TPAC that were present for the meeting, were there because there was a belief that the arts, in a myriad of ways, were connected to other community issues such as entertainment, tourism, working with youth and civic engagements. She said the arts and culture could help solve many situations the community was in and gave some examples on how she thought the arts helped.

Karen Falkenstrom read a piece from Chuck Graham, who wrote about Tucson's performing arts while employed by the Tucson Citizen. Mr. Graham spoke about the importance of the arts in Tucson and funding by the City of Tucson.

George Favela and June Webb-Vignery, Metropolitan Education Commission (MEC), spoke asking that the City's funding allocation match the County's funding. Ms. Webb-Vignery gave some background history regarding the importance of matching funding by the City for the MEC. Mr. Favela added that the MEC appreciated everything the Mayor and Council had done, but needed anchor funding by both the City and the County in order to leverage for any outside funding.

It was moved by Council Member Fimbres, duly seconded, and passed by a voice of 7 to 0 to close the public hearing.

Mayor Walkup announced the Council would stand adjourned and convene a special meeting for the adoption of the budget.
