

Minutes of MAYOR AND COUNCIL Meeting

The Mayor and Council of the City of Tucson met in regular session in the Mayor and Council Chambers in City Hall, 255 West Alameda Street, Tucson, Arizona, at 5:50 p.m., on Tuesday, September 28, 2010, all members having been notified of the time and place thereof.

2. INVOCATION AND PLEDGE OF ALLEGIANCE

The invocation was given by Chaplain Jason English, Davis Monthan Air Force Base, after which the Pledge of Allegiance was presented by the entire assembly.

3. MAYOR AND COUNCIL REPORT: SUMMARY OF CURRENT EVENTS

Mayor Walkup announced City Manager's communication number 435, dated September 28, 2010, was received into and made part of the record. He also announced this was the time scheduled to allow members of the Mayor and Council to report on current events and asked if there were any reports.

- e. Council Member Fimbres reminded the public about the deadline to register to vote for the November 2nd General Election. He also invited the public to attend the Ward 5 Townhall on Proposition 400 and gave an update on the site development work for Costco in the Tucson Marketplace at the Bridges.
- f. Council Member Kozachik invited the public to a fundraiser for Reid Park. He also urged the public, if they were not already, to register to vote.

It was moved by Council Member Cunningham, duly seconded, to forward liquor license applications 5b1, and 5c1 through 5c9 to the Arizona State Liquor Board with a recommendation for approval.

Council Member Kozachik asked the City Attorney if he should recuse himself from voting on the liquor license applications, as two of the requests for special events were for the Athletic Department at the University of Arizona.

Mike Rankin, City Attorney, thanked Council Member Kozachik for raising the issue, and suggested that he recuse himself from voting.

The motion to forward liquor license applications 5b1, and 5c1 through 5c9 to the Arizona State Liquor Board with a recommendation for approval, passed by a roll call vote of 6 to 0 (Council Member Kozachik recused).

6. CALL TO THE AUDIENCE

Mayor Walkup announced this was the time any member of the public was allowed to address the Mayor and Council on any issue except for items scheduled for a public hearing. Speakers were limited to three-minute presentations.

- a. Robert Reus spoke in opposition to Proposition 400.
- b. Mikki Niemi spoke about his concerns regarding the City building a new hotel downtown.
- c. Diane Lopes spoke in opposition to raising Sun Tran bus fares.
- d. James Hannley, representing Protect Local Control: No on Prop 401, spoke in opposition to the proposed Charter changes.
- e. Joseph Sweeney spoke about funding spent on illegal aliens, and his opposition to the City cutting funding for Access Tucson.
- f. Michael Coiro, American Federation of State, County and Municipal Employees (AFSCME) Local 449 Executive Director, spoke in support of Proposition 400. He also spoke about his concerns over the City's disregard of the negotiated agreement between the City of Tucson and the AFSCME employees.
- g. Shannon Cain gave the sixth installment of her performance piece entitled, "Tucson, the Novel: An Experiment in Literature and Civil Discourse."
- h. John Kromko spoke about the need for an ordinance stating that everything had to go to public bid, referring to Cable 12 equipment being given to the University of Arizona.
- i. Mark Spear spoke about requirements dealing with photo enforcement as listed under *Arizona Revised Statutes* § 28.12.04, which states there should be at least two signs placed in a location before photo enforcement systems.

8. PUBLIC HEARING: BINGO LICENSE - SACRED HEART CHURCH, 601 EAST FORT LOWELL ROAD, CITY NUMBER 201

Mayor Walkup announced City Manager's communication number 443, dated September 28, 2010, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on a request for a bingo license at Sacred Heart Church located at 601 East Fort Lowell Road. He asked if the applicant was present and if they had any comments to make before beginning the public hearing.

Leland S. Campbell, the Applicant, said he did not have comments to make.

Mayor Walkup announced the public hearing was scheduled to last for no more than one hour and speakers were limited to five-minute presentations. He asked if there was anyone in the audience wishing to be heard on this item. Hearing no one, he asked for a motion to close the public hearing.

It was moved by Council Member Uhlich, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

It was moved by Council Member Uhlich, duly seconded, and carried by a voice vote of 7 to 0, to forward the bingo license application for Sacred Heart Church to the Arizona Department of Revenue with a recommendation for approval.

9. PUBLIC HEARING: EXTENSION OF THE PANTANO RIVER PARK PROJECT FROM MICHAEL PERRY PARK TO SELLAROLE ROAD AND USE OF SURPLUS PHASE I FUNDING FOR THIS PURPOSE.

Mayor Walkup announced City Manager's communication number 439, dated September 28, 2010, was received into and made part of the record. He also announced this was the time and place legally advertised for a public hearing on the extension of the

Pantano River Park Project from Michael Perry Park to Sellarole Road and use of surplus Phase I funding for this purpose. He announced the public was scheduled to last for no more than one hour and speakers were limited to five-minute presentations.

Mayor Walkup asked if there was anyone in the audience wishing to be heard on this item. Hearing no one, he asked for a motion to close the public hearing.

It was moved by Council Member Cunningham, duly seconded, and carried by a voice vote of 7 to 0, to close the public hearing.

Mayor Walkup asked the City Clerk to read Resolution <u>21630</u> by number and title only.

Resolution No. <u>21630</u> relating to parks; requesting an extension of the Pantano River Park Project from Michael Perry Park to Sellarole Road and use of surplus Phase I funding for this purpose; and declaring an emergency.

Council Member Cunningham recognized Vice Mayor Scott for her leadership in making this extension happen which connected all the rivers for bicycle riders from Cienega Creek to Tanque Verde Creek to the Santa Cruz River and Julian Wash.

It was moved by Council Member Cunningham, duly seconded, and passed by a roll call vote of 7 to 0, to pass and adopt Resolution <u>21630</u>.

10. PROFESSIONAL SERVICES CONTRACT AMENDMENT: WITH DOWNTOWN TUCSON PARTNERSHIP FOR CONSULTING SERVICES (CONTINUED FROM THE MEETING OF SEPTEMBER 21, 2010)

Mayor Walkup announced City Manager's communication number 442, dated September 28, 2010, was received into and made part of the record. He asked the City Clerk to read Resolution <u>21628</u> by number and title only.

Resolution No. <u>21628</u> relating to Consultant Services; authorizing and approving Amendment One of the contract for consultant services between the City of Tucson and Downtown Tucson Partnership, an Arizona Non-Profit Corporation; and declaring an emergency.

Council Member Fimbres asked staff if the Rio Nuevo District Board had any financial obligations for the Downtown Tucson Partnership.

Michael Rankin, City Attorney, replied he was not aware of any.

It was moved by Council Member Fimbres, duly seconded, to pass and adopt Resolution 21628.

Council Member Kozachik made a few comments in support of the amendment and commended the leadership of Michael Keith, Downtown Tucson Partnership (DTP) Executive Director. He said he had a question in reference to the Housing and Urban Development (HUD) Section 108 financing. He asked the Assistant City Manager how the amendment furthered the relationship involving the DTP and the Industrial Development Authority (IDA).

Sean McBride, Assistant City Manager, replied that Albert Elias, Housing and Community Development Director, was developing the Section 108 application for review by HUD's regional office. He stated that Mr. Elias, while putting the amendment together, was in consultation with the IDA and his next step was to work in partnership with both the IDA and the DTP to tie up any loose ends. Mr. McBride added that the parameters and details of the relationship were not yet finalized, but hoped they would be within the next few weeks.

Council Member Kozachik said he wanted to be assured that the IDA was not left out of the equation once finalized. He commented there was nothing in the proposed amendment that specifically related to expanding participants in the bid, and should be as the City struggled through the budgetary process. He also expressed his feelings about the Mayor and Council being asked to adopt a contract that had been in effect for two months, stating that they should be allowed to vote on items before they became effective.

Comments were made by Council Member Uhlich and Mayor Walkup regarding the value of the contract with the DTP.

Resolution 21628 was passed and adopted by a roll call vote of 7 to 0.

11. APPOINTMENTS TO BOARDS, COMMITTEES AND COMMISSIONS

Mayor Walkup announced City Manager's communication number 438, dated September 28, 2010, was received into and made part of the record. He asked for a motion to approve the appointments in the report.

It was moved by Vice Mayor Scott, duly seconded, and carried by a voice vote of 7 to 0, to approve the appointments of Christopher Domin to the El Presidio Historic Zone Advisory Board (EPHZAB) in the Special Qualifications category, and Emma Juan and Cecilia Vindiola to the Pima County/Tucson Women's Commission (PCTWC).

Mayor Walkup asked if there were any personal appointments to be made. There were none.
