

Minutes of MAYOR AND COUNCIL Meeting

Date of Meeting: November 20, 2007

The Mayor and Council of the City of Tucson met in regular session in the Mayor and Council Chambers in City Hall, 255 West Alameda Street, Tucson, Arizona, at 5:44 p.m., on Tuesday, November 20, 2007, all members having been notified of the time and place thereof.

1. ROLL CALL

2. INVOCATION AND PLEDGE OF ALLEGIANCE

The invocation was given by Reverend Draigg Phillips after which the Pledge of Allegiance was presented by the entire assembly.

a. Anne Doris, on behalf of Cox Communications, presented a check for fifty thousand dollars to the City of Tucson to help expand the "Schools Plus Jobs" program into more schools within Tucson.

Roger W. Randolph, Chief Deputy City Clerk, announced Susie Rogers would be assisting with anyone in the audience needing Spanish language translation for items listed on the agenda.

3. MAYOR AND COUNCIL REPORT: SUMMARY OF CURRENT EVENTS

Mayor Walkup announced City Manager's communication number 626, dated November 20, 2007, was received into and made a part of the record. He also announced this was the time scheduled to allow members of the Mayor and Council to report on current events and asked if there were any reports.

a. Council Member Uhlich announced the Ward 3 office would host an open house on December 1, 2007, sponsored by the Watershed Management Group. The event would include a site tour and slide presentation of the Ward 3 water harvesting demonstration site and discussion on community and neighborhood water harvesting.

It was moved by Council Member West, duly seconded, and carried by a voice vote of 7 to 0, to forward liquor license applications 5b1 through 5b5, 5c1, and 5d1 to the Arizona State Liquor Board with a recommendation for approval.

6. CALL TO THE AUDIENCE

Mayor Walkup announced this was the time any member of the public was allowed to address the Mayor and Council on any issue. Speakers were limited to three-minute presentations.

- a. John Watt requested the Mayor and Council investigate his complaint that Tucson Police Department and Animal Control have not followed up on his request for information regarding a dog-biting incident. He also made suggestions on how to remedy illegal immigration.
- b. Frank Salbego, President of Eastside Neighborhood Association, thanked Council Member West for all her efforts while serving at Ward 2. He invited everyone to a tree dedication ceremony on December 1, 2007, in honor of Council Member West.
- c. Roy Warden submitted a petition to Mayor Walkup for a proposed future agenda item asking for full disclosure of all City of Tucson policy as it related to illegal immigration and homeland security issues.

It was moved by Vice Mayor Scott, duly seconded, and carried by a voice vote of 6 to 1 (Council Member West dissenting), to direct the City Attorney to prepare a written response to the petition filed by Roy Warden.

- d. Laura Leighton spoke about the immigration system and its lack of enforcement.
- e. Alexander Monarrez Maldonado read excerpts from the poem "I am Joaquin" by Rodolfo "Corky" Gonzales.
- f. Joe Sweeney spoke about illegal immigrants and enforcement of immigration laws.
- g. Zaliah Zalkind suggested the Mayor and Council establish a policy to prohibit the Tucson Police Department from enforcing immigration laws, as it was not in its jurisdiction.
- h. Russell Dove spoke about his indignation at other cultures being promoted above the American way of life. He stressed federal immigration laws needed to be enforced.
- i. Michael Toney spoke about the new hotel and arena to be built for the Rio Nuevo district using tax increment financing (TIF).

Council Member Uhlich announced her appointment of Sean Sullivan to the Planning Commission.
