Housing First Subcommittee of the Commission on Equitable Housing and Development meeting

Call to Order/Roll Call, and Introductions

The meeting was called to order at 4:00 pm by Chair Tisha Tallman. Roll call was taken, and a quorum was established. *No Action Taken*

- 2. Approval of the June Minutes approved as submitted
- **3.** Housing First Update Elaine, Supervisor of the Homeless System Improvement with the City spoke about the Housing Central Command Initiative that is coming out of some HUD funding through TPCH to help house folks from encampments into housing. Also spoke about the gaps analysis which was discussed at the board meetings a while back with both members of the Continuum of Care board as well as Entitlement funders regarding programming for people experiencing homelessness in Pima County. Elaine also mentioned about the great work being done around Housing First like cooling centers, mobile showers and soon HUD will be releasing an Annual notice of funding opportunities for the Continuum of Care program and finally recently was a release of notice of funding opportunity for the construction of permanent supportive housing so upon the Continuum of Care board approves the RFP it will up a go. Ernesto put into the chat a story from the AZ Daily Star about four Housing First employees who previously experienced unsheltered life and now are working with their unsheltered peers.

4. Rachel Milne, with he Office of Homeless Solutions, City of Phoenix – Rachel shared a slideshow PowerPoint presentation on the Office of Homeless Solutions (OHS) and discussed the type of support they offer which was created 2 years ago by the City Mayor, Director and City Council, prior to this the City funded most of the homeless service providers which were mostly shelters, some rapid rehousing, some prevention but wasn't really active in homeless solutions. So, in creating the OHS it created a direct service delivery, they created their own outreach teams, buildings, safe outdoor space, shelters and purchased a hotel to convert into affordable housing and have a hands-on approach at the City when it comes to solutions. Most of the focus is on shelters since that is most needed.

5. Elizabeth DaCosta, Director of Housing with AHCCCS – Elizabeth presented a slideshow on Housing & Health Opportunities (H20) and the Housing Accelerator.

- Permanent supportive housing services
- Outreach and Education services
- Transitional housing for 6 months
- One time transition and moving costs
- Home accessibility modification and remediation

• Must be experiencing homelessness and Z code and Identify through HMIS

• Must have SMI Designation and be diagnosed with a chronic health condition or currently in a correctional facility with a release date scheduled within 90 days or released from the correctional facility within last 90 days.
