3. Review and Approval of 11/21/2025 Draft LAR and Meeting Minutes

6. Staff Announcements

Staff informed the Board that Ascent Tucson, the proposed apartment complex in the Sunshine Mile, has been put on hold, since developer is working through the economics as a result of market dynamics.

Additional Board Discussion

Staff confirmed Board currently has a full roster, with Ms. Anthony's term expiring on July 2026, and Ms. Clement's second term expiring on September 2027. Staff also clarified the Trader Joe's on Broadway Bl. Project did not go through SMD-DRB review, since the applicant did not select the Sunshine Mile District (SMD) overlay as a tool for redevelopment. Staff will share the links to the Grant Road Investment District (GRID), the Sunshine Mile District (SMD), and the Community Corridors Tool (CCT), for which the DRB may be involved in the review of certain projects. A training on CCTs will be scheduled with the DRB and staff prior to the review of a CCT project by the DRB.
