### LETTER

from Council Member Fimbres Dear Friends.

Monday, March 28th will mark the eighth anniversary for the City of Tucson Cesar Chavez Holiday and Day of Service. Cesar Chavez was an educator, environmentalist and a civil rights leader. One of his most famous sayings was: "We cannot seek achievement for ourselves and forget about progress and prosperity for our community. Our ambitions must be broad enough to include the aspirations and needs of others, for their sakes and for our own." Chavez's words ring true, especially during this time with the COVID-19 health crisis. We need only to look at Cesar Chavez's motto, "Si, se puede." We can win when we work together. The beauty of Tucson and Pima County is that we do not scapegoat, place blame or point fingers, we roll up our sleeves to solve the challenges that we face. As Cesar Chavez said, "We draw our strength from the very despair in which we have been forced to live. We shall endure. The people united will never be defeated." Powerful words said by Cesar Chavez that will help us get through this health crisis. Dr. John Arnold is one of many, marking the 55<sup>th</sup> anniversary of PPEP Tech and the "La Tortuga," the famous green bus teaching English and basic education, to the same Bracero farm-workers he had ministered to in the past, helping them prepare for life in America, gaining education through "Portable, Practical Educational Preparation," or PPEP, providing services to millions in need. The Arizona Cesar E. Chavez Holiday Coalition will also be honoring and recognizing workers who have sacrificed their lives during the pandemic and those who are now resting in power, with a vigil during the annual event on March 31st at 5pm. The event will take place at Rudy Garcia Park.

The City of Tucson is the first and only city or governmental entity in Arizona to have a paid holiday and day of service for Cesar Chavez. I want to thank my colleagues: Shirley Scott, Karin Uhlich, then Mayor Jonathan Rothschild, Regina Romero, Steve Kozachik and Paul Cunningham on the Council and the many organizations who joined me in support for the City of Tucson true Cesar Chavez holiday in 2014. His selfless dedication for farm worker and worker rights, economic justice, civil rights, environmental justice, peace, nonviolence, empowerment of the poor and disenfranchised, is a monumental legacy that will inspire all and the generations to come. Si Se Puede.

# **CHERRYBELL UPDATE**

On March 8, 2022, the U.S. Senate voted 79-19 for final approval of the Postal Reform Act of 2022. The Postal Reform Act eliminates the requirement that the U.S. Postal Service (USPS) pre-fund retiree health benefits for 75 years. Eliminating the pre-funding requirement will help shore up USPS finances and provide greater stability for the postal service and keep processing centers like Cherrybell



open and running. It shifts most medical costs for postal service retirees to Medicare. It also authorizes USPS to provide non-postal services on behalf of State, local and tribal governments, require it to publish data on delivery performance. It requires USPS to maintain six-day delivery. It also expands the authority of the USPS inspector general over the Postal Regulatory Commission. This is a major victory in our 11-year battle to keep the Cherrybell Post Office and Processing Center open and functioning, serving 1.5 million people, the two tribes, seniors, veterans, small businesses and other companies in Tucson and Southern Arizona. The stronger financial footing for the USPS provides us the opportunity to restore services that were previously consolidated in Phoenix, including local sorting and bringing back the Tucson postmark. I am grateful to the Arizona Congressional delegation, business, labor and community leaders across Tucson and Southern Arizona, and to my fellow Mayor and Council, for their leadership and support during this 11-year battle for our community and Cherrybell. The Postal Reform Act, H.R. 3076, passed the House of Representatives by a vote of 342-92. The bill goes to President Biden. He is expected to sign the bill.

# **9/11 FIREFIGHTERS STATUE PRESENTATION**

On Monday, February 28th, I had the honor of presenting the Tucson Fire Department with the 9/11 Image of Hope Statue at a ceremony at Fire Central. This statue was presented for the men and women of the Tucson Fire Department, who do so much for this community through

their work and commitment, as well as giving Tucsonans hope during those times the Tucson Fire Department is called to help. This statue is in honor of those who lost their lives in 9/11 and for the Tucson Firefighters who went to help in New York after the tragedy, so that we never forget. The statue was purchased by Vikki Marshall, a former Pima Community College Governing Board Member. Marshall had purchased the statue in honor of her Uncle Richard Marshall, who served as the Commander of a Volunteer Fire Department and for the work she did to help firefighters during that time. I want to thank the men and women of our Tucson Fire Department for their commitment to their work saving lives in our community, We owe the Tucson Fire Department a debt of gratitude for what they do.









### **TUCSON FIRE STATION #14**

At the February 23rd Mayor and Council meeting, the Mayor and Council approved a proposal to go into negotiations with the Sunnyside School District for two parcels, located on the west side of South Nogales Highway, north of East Drexel Road, to build the new Fire Station 14, as part of the Proposition 101 Public Safety Measure. The vote was unanimous for the



proposal. I will provide further updates on this in future editions of the newsletter.

### **PROPOSITION 411**

The City of Tucson is asking the good citizens to extend the existing temporary half-cent sales tax for an additional 10 years. This extension will not increase the City's current sales tax rate of 2.6%. The funds collected through the half-cent sales tax over the 10-year period will be used solely for neighborhood street improvements and system-wide street safety projects. The estimated sales tax revenue over this 10-year period is projected to be \$740 million to be used solely for improvements to neighborhood street conditions and system-wide street safety. Of that estimated funding, 80%, or \$590 million, will be dedicated to improving the condition of City neighborhood streets; and 20%, or \$150 million, will be dedicated to safe street improvements that benefit all users and modes. Safety improvements can include projects such as street lighting, sidewalks, bicycle network enhancements, traffic signal technology upgrades, and traffic-calming features.

Accountability and oversight commissions ensure that the funds collected from the temporary half-cent sales tax are only spent for the purposes approved by voters. Over the last decade, citizens' accountability and oversight commissions have served taxpayers by overseeing and monitoring projects and expenditures for the voter-approved 2017 half-cent sales tax and both the Proposition 409 and 407 bond packages. The Independent Oversight and Accountability Commission will select and prioritize Proposition 411 neighborhood street improvement projects. The City's Complete Streets Coordinating Council, a group of citizens appointed by the Mayor and Council, in addition to technical experts, will oversee the selection of Proposition 411 safe street projects. The four major safe street project categories and corresponding funding allocations include:

Bicycle Network Enhancements	20%	\$30M
System-wide Safety Improvements	30%	\$45M
Traffic Signal Technology Upgrades	20%	\$30M

### **TEP UPDATE**

TEP Update: The City of Tucson Planning Commission met on March 16<sup>th</sup>, relating to the proposed amendments to the Unified Development Code (UDC) that would create a special exception process for consideration of requests for relief from the City's undergrounding requirements for utilities located in the rights of way along Scenic Corridor and Gateway Corridor routes. This proposal would provide a public process for the consideration of allowing the installation to go overhead in defined areas where special circumstances support giving relief from the undergrounding requirement. 

#### United Way of Tucson's COVID-19 Policy:
