SUBJECT: Plastic Bag Reporting per City Code Chapter 15, Article VII
Retail Establishments – Second Reporting Period: Quarter 3, 2013

In accordance with the provisions of the City's Plastic Bag Ordinance, Retail Establishments are required to report quarterly to the Environmental Services (ES) Director, through an independent auditor, the following information:

- Total number of single use plastic bags given out
- Tons of film plastic collected through the plastic bag and film collection in-store program
- Number of single use plastic bags per transaction
- A list of all Retail Establishments reporting during the initial reporting period.

Two changes occurred between the Second Reporting Period and the First Reporting Period. The first change is Walgreens reported this period adding 44 stores to the list of reporting stores. No other retail establishments were added to or deleted from the list.

The second change is the stores reported tons plastic bags recycled, without store film plastic included. The ordinance requires a quarterly meeting between the Retail Division Managers and the City of Tucson. During the first meeting on August 28th 2013, each store committed to separating out plastic bags from store film plastic and reporting the pounds of plastic bags recycled. Consequently, the pounds/ton of store plastic film was not available to be reported this quarter.

The auditors, Smith Accounting & Business Solutions, PC, provided the following information to ES as required on October 31, 2013. The results were confirmed by the independent auditor on November 5, 2013.

The List of Retail Establishments reporting during the Third Quarter, 2013 is attached. Some of the stores listed are not within City limits because some retailers opted to report all their stores with Tucson addresses whether they are in the City or not. The Arizona Food Marketing Association (AFMA) worked with each chain and informed them of the ordinance requirements. The list of stores needs to be consistent each quarter in order to track trends in the data.
